

Black contractors threaten court action

Uproar over

tenders for
new prisons

Johannesburg â\200\224 The National
Black Contractors Forum threat-
ened yesterday to take the public
works department to court over
the tender adjudicating process
for the construction of the new
prisons, which will be privately
built and operated.

The prisons are to be built
from the first quarter of next
year, and operated and main-
tained over the next 25 years in
deals with a value of R10,7 bil-
lion, according to Kobie Willem-
se, the forum's secretary-general.

Public works announced the
five short-listed bidders in
August, and the forum was not
among them. Willemse said the
shortlisted companies were all
â\200\234people with powerâ\200\235. He alleges
that the department was sup-
posed to submit all documenta-
tion to the State Tender Board
but did not do so.

â\200\234The department withheld in-
formation, and the State Tender
Board practically signed blank
cheques for the department's rat-
ification process,â\200\231 said Willemse.

He said the public works de-
partment conducted the tender
bid without reference
to several acts, render-
ing the process illegal.
The forum represents
about 600 contractors
from small, medium, .

and micro-enterprises
spanning services, construction services, :
goods and technology.

Willemse said
Sipho Mzimela, the
minister of correctional services, circumvented the
procurement principle when he
tabled a bill in parliament. The

National Black Contractors -

Forum intended to apply for legal
aid to challenge Mzimela's actions in the Constitutional Court.

He said the bureaucrats relied
on old-line, larger-established
firms in a competitive bidding
process, rather than smaller, less
well-known competitors.
