PENTECH POST-ACCESS BURSARIES

Thank you very much for sending me the Memorandum of Agreement covering funding for the above programme. I wanted to let you know that we have not yet signed this document, as we have some areas of concern which we would like to raise with you.

Firstly, the final page for our signature should read:

"FOR THE BATLAGAE TRUST" (not lfor The African National Congress')

Secondly, we wanted to ask whether Interfund would consider the possibility of transferring these funds directly to the Peninsula Teohnikon.

However, we were informed today by our bank that an amount of R1 284 729 has been deposited by Interfund. Therefore, we gratefully aCknowledge receipt of this grant, and enclose a copy of the bank deposit voucher for your records.

Since we now have the funds, but the Memorandum of Agreement is not yet signed, we wish to explore the possibility of transferring the entire amount to Pentech, with there being an agreement between Interfund and Pentech for the administration of this grant.

As you know, the Batlagae Trust agreed in 1993 to administer the DANIDA funds for Post-Access Programme A training at Pentech. We saw this as_a one'off situation, and we did not envisage undertaking any further administration duties. I regret that this sentiment was not conveyed to Interfund earlier, and hope that you will understand our position in wanting to reduce the Batlagae Trustis administration costs.

I look forward to hearing from you on this matter.
