I have received the attached letter from the International School containing updated list of ANC students enrolled at the school for the 1988/1989 school year.

I should be grateful if you would kindly check whether UNESCO has received Study Grant Forms for all the students mentioned therein, because it has been difficult for this Office to accommodate the payment of school fees for these students with your instructions. Your cable 110 6121 instructed this Office to pay January/ December 1988 stipends covering the following students:

- Ana Cristina Boitumelo MabuzaUS\$ 1070.00

- Mangoba Manyosi US\$ 1070.00

Mxolisi Zuma 'US\$ 1070.00

Accordingly a cheque was issued to International School for the total amount of US\$ 3210.00, however the school returned the cheque to our Office stating that they do not understand this payment.

Also in your cable nO 34975 you requested me to pay adjustment stipends as follows:

- Boitumelo Mabuza US\$ 100.00

- Mangoba Manyosi US\$ 100.00

Therefore, a cheque was issued with a total of US\$ 1247.00 to International School but here again the cheque was returned by them as they do not know to what it refers.

However, for further information, I asked the International School to state exactly what was the payment situation and what was due by UNESCO. On 28 June 1988 I received the attached letter where they informed us of the following:

I should like to draw your attention to the attached copy of a letter from the International School dated 7 June 1988 together with copy of a notice of 28 March 1988 where we were advised that as from 1988 the school fees have been increased accordingly.

The school also informed us in the same letter that they should be paid three times a year or at least by the end of each school year. Actually the payments are authorized with a six months delay which is quite inconvenient for them. '

For the future, it was agreed that the school should give an actual list of the enrolled students and fees to be paid to avoid misunderstandings.
