Every effort should be made to appoint some senior Nigerians on the staff in Nigeria to facilitate co-opration with Nigerian authorities.

## Accountant:

It was decided that an Accountant, a Nigerian if possible, be appointed with minimum delay to assist administer the finances of the office in Lagos.

Banking Arrangements:

The meeting decided that a separate Bank Account for this programme should be opened. Budget:

It was noted that although the Australian Government had provided Australian \$1.96 Million, that was sufficient to cover costs of 265 students only and that additional Funding was required for the remaining 235. It was Further noted that funds so far released by Australia would last only up to the 30 June 1991. The additional funding required totalled US\$1.3 Million over the next two years. Mr T.T. Nkobi confirmed, first, that the Government of Nigeria had offered Niara 500 000.00 as their contribution to the project and, secondly, that the ANC accepted full responsibility for raising the required US\$1.3 Million referred to in the preceding paragraph.

It was agreed that a report would be presented to the next meeting of the Trustees on Draft Accounts and the Budget of the Trust.

Mr Nkobi said that SIDA Funds referred to in the report were in fact already committed to other projects. However, he would make every effort to secure alternative funds for the Trust during March 1991.

In response to the point raised by SIDA regarding the future re-location of the headquarters of the Trust, the meeting decided after some discussion that, first, London would remain the Headquarters of the Trust; secondly, that as work of the Trust in South Africa grew, the work in London would be reduced correspondingly; thirdly, that even in the long-term it would be desirable to retain the office in London to support specialised postgraduate studies.

It was further noted that as a consequence of this change of name, Mr B M Birnberg would arrange for the reproduction of new copies of the Memorandum and Articles of Association of the Trust.

Resignation - Mr Michael Hyde-Smith:  ${\tt Mr\ Hyde-Smith's\ resignation},\ {\tt effective\ 1\ January}$ 1991, was noted. The Council decided that a letter be sent to him by the Chairman, thanking him for the many years of valuable services to the Trust and wishing him well in the coming years. It was further agreed to replace Mr Hyde-Smith as Treasurer (but not as a Trustee) with Mr Phillip Harrison whose CV was circulated. Mr Harrison would work for one day a week as Treasurer and Consultant and would help mainly with the financial administration of the Trust. His salary would be agreed with the Chairman and Director. The appointment was made under Paragraph 37 of the Articles of AsSociation. Under Article 36 of these Articles Mr Harrison would be authorised to be a cheque signatory.

The Director's Report:

5.1 Ni erian Pro ramme (500 students)

As outlined in my report to the last meeting of the Council held on the 4 December 1990, the paradox of our situation is that as old South African exiles/refugees prepare to return to South Africa in the light of the political changes underway in that country, new waves of refugees/exiles are fleeing the country from the Natal Civil War into exile in the Frontline States. At the latest count there were nearly 2 000 of these people in Zimbabwe, Zambia and Tanzania. The ANC arranged for 500 of these students to be placed in schools in Nigeria. The Government of Australia agreed to fund the programme at a cost of A\$1.96 Million. The Council agreed at its last meeting to administer this programme, if asked by the ANC to do so. We were Formally asked to do so at a meeting held on the 17 December 1990, in Johannesburg, South Africa, between the Australian High Commissioner to Zambia (H E Dr Helen Ware), Treasurer- General of the ANC, ANC Secretary For Education (Mr S M Choabi), the ANC Chief Representatives in Australia (Mr Eddie Funde) and Nigeria (Mr George . Nene) respectively and myself.

5.2 Implementation of the Programme

Inorder to implement this programme the Australian Government, nominated Austcare, an Australian Non-Governmental Organisation (N80) to work together with the Luthuli Memorial Trust. They appointed Mr Ross Hardy as their Project Co-Urdinator For the programme. He will visit Nigeria From time to time, alone or with us, to monitor the implementation of the programme. Copies of his mission reports to the Government will be sent to us for information.

Visit to Lagos, Nigeria, 15 - 20 February 1991 Mr Ross Hardy and the Director visited Lagos from the 15 - 20 February 1991 to familiarise themselves with the situation of the students on the ground. We arrived in Lagos On the same day as two chartered Flights arrived in Lagos with 200 students from Tanzania - three had arrived from Lusaka on the same flight with us. This brought the total number of the students in Nigeria to 453. Another 47 were expected to arrive any day. Categories

Of these students three are primary school children - the youngest is 12 years old; 49 are secondary school children and 401 are Technical College/University students. Reception

The students were received by the ANC Chief Representative in Lagos, assisted by Mr Richard Sibengile, Luthuli's temporary administrator in Lagos. Lagos is hot and humid, and many students Found that hard to take. Then there were other issues to settle, viz. visas, temporary accommodation at the reception centres, Feeding, transport to schools/colleges/universities in the 21 States of the Federation of Nigeria, payment of tuition Fees, maintenance allowances, money for books, pocket money etc. Messers Nene and Sibengile worked tirelessly on these issues all the time we were in Lagos.

#### Placements

As indicated in the preceding paragraphs, these students had to be transported by road to educational institutions in 21 States of the Nigerian Federation. Actual costs of the operation are not yet available, but they may be expected to be substantial.

### Office Accommodation

Messers Nene and Sibengile had already obtained a lease of a two-storeyed private house for use as offices For Luthuli - apparently Nigerian Town Planning Regulations allow that to be done. We await copies of the lease. The accommodation is substantial - six rooms, a kitchen, bathroom, toilette etc. It is sufficient to accommodate all necessary professional and general services staff.

Office Furniture and Eguipment

Orders were placed For office furniture and equipment, viz. tables, chairs, Filing cabinets, type-writers, word processors, computers etc.

Office Cars

Two vehicles were ordered for use by the office staff - one a 12-seater Kombi and the other a Range Rover. Distances are great in Nigeria and public transport needs to be supplemented by own transport; the staff will need the vehicles. Provision was made in the budget for their maintenance and repairs.

5 10 Staffing

5 11

The office does not have a head at present. Mr Richard Sibengile acts as one temporarily. He understands that he cannot be appointed to fill the post permanently or on a long-term basis. His CV together with CVs of three ladies we met are attached to this report as Annexes 1,2,3 and 4. The three ladies are retired South African teachers, married to Nigerians and having long experience of life and work in Nigeria. Their assistance to the students should prove invaluable. Council is asked to approve the appointment of all four persons to the posts of Counsellors at a salary grade of US\$6 000 per annum each. The recommendation is that Miss Patricia Mtshali (whose CV was reported to the last meeting of Council), be offered the post of Co-Ordinator of the Programme in Nigeria at the salary grade of US\$12 000 per annum. Miss Mtshali is currently employed in Cardiff, Wales and it is uncertain whether she will be available for the post. The staff will, ofcourse, be answerable to the office here in London.

#### Accountant

No Accountant has been identified so far. Mr Nene has been asked to recruit this key officer without delay. His response is awaited.

### 5 12 Banking Arrangements

These were initially in the hands of Mr George Nene, ANC Chief Representative in Lagos. He has, however, now handed over this responsibility to Mr Richard Sibengile, inorder to distance Luthuli Trust From the ANC. It is, clearly, unsatisfactory that Mr Sibengile should be the sole signatory OF Luthuli Cheques. This is something that should be remedied as soon as at all practicable.

### 5 13 Budget

Attached to this report as Annex 5 is a Draft Budget that Mr Roass Hardy prepared after discussing the whole programme with all of us in Lagos. Mr Hardy will refine and finalise it in Australia and then send us a Fair copy of it - the original will be Forwarded by him to the Australian Government. It should be noted that the budget is US\$1.3 Million short of the required funds. The ANC has agreed to find this money.

5 14 Austcare/Luthuli Working Relations
Mr Hardy will prepare a draft agreement to regulate our
working relations with Austcare - there is a comparable
agreement between Austcare and the Government of Australia.
The expectation is that the document will be a short
workmanlike one, not too detailed and so burdensome.
5 15 Mr R Hardx's Visit to London

Mr Hardy stopped over in London on the 21 February 1991, for one day. We hosted a lunch for him at the Commonwealth House/Society, Northumberland Avenue, London WC2. The Right Reverend Hugh Montefiore, Mr John Matthew, Mr B M Birnberg were, fortunately, able to attend the lunch and to have informal discussions with him. Ms Patricia Mtshali, the Director and the Administrative Secretary were in attendance. He\_expects to return to Nigeria before June 1991 - to visit the educational institutions where our students are based. The Director will also do likewise. It is, in fact, essential for such a visit to take place soon inorder to appoint an Accountant and to make suitable banking arrangements for Luthuli in Lagos.

5 16 Mr John Matthew

He has wide experience of life and work in Nigeria. It was, therefore, agreed at the Hardy lunch, that it would be useful if Mr Matthew would visit our students in Nigeria and advise generally on the implementation of the programme.

## 5 17 Related Programmes

The ANC is negotiating with the Governments of Kenya and Zimbabwe for the placement of another 500 students in Kenyan educational institutions and 700 in Zimbabwean educational institutions. It is intended that once negotiations are concluded, Luthuli Trust should be requested to administer the programmes. The Trust could approve of this in principle, provided that adequate Funds are made available For the effective implementation of the programme.

Funding

SIDA/ANC/Luthuli Consultations, 12 - 14 February 1991, Johannesburg, South Africa

SIDA agred at these consultations to grant Luthuli SEK3 million For the 1991/92 academic year. At the same meeting SIDA announced that they had a considerable amount of uncommitted funds for the SIDA financial year ending on the 30 June 1991. These Funds were available for use at the direction of the ANC. We, therefore, asked both the ANC and SIDA to make these funds available to Luthuli. No reply to this request has been received from either SIDA or the ANC.

Donors' Conference, Arusha, Tanzania, 6 - 8 Februar 1991 The ANC convened 8 Donors' Conference in Arusha, Tanzania, From the 6 - 8 February 1991, in order to explain its needs to governments, international organisations, NGDs, which had assisted ANC projects over the years. Over 200 delegates attended the Conference. In his opening address to the Conference, the Treasurer- General of the ANC, Mr Thomas T Nkobi, commended Luthuli to the donors for assistance. We also distributed documents on our work amongst the participants.lt is impossible to know what effect this had on the donors since they were not at the Conference to pledge any funds.

Funding is now a major problem facing the Trust. Large numbers of black South African exiles/refugees are anxious to acquire some training before they return to South Africa in 1991/92. Increasing numbers turn to us For assistance. All need and deserve help. We can help them only if we are able to raise sufficient funds For the programme. Trustees will no doubt do what they can to meet these needs.
