All Heads of State and Government condemn the continued atrocities of the ex-FAR, the Interahamwe and their allies, pledge to work together to prohibit future atrocities in the Great Lakes region, including those aided and abetted by external arms suppliers, call for the revitalization and expansion of the UN Arms Flow Commission, and are committed to publicize and duly consider its in\201ndings;

Afn'can Heads of State and Government pledge to deny eXtremist networks the use of their territory, postal services, airports,  $i_7\201$ nancial institutions, passports, road n etworks

and communications systems. The Summit calls upon all states to implement tight controls over these networks abroad;

All Heads of State and Government pledge to support the efforts of the OAU Eminent Personalities Study of the Rwanda Genocide and the Surrounding Events, and to duly consider its  $i\sqrt{201}$ ndings and recommendations;

The United States commits itself to working with regional partners and others to begin exploring, within one month  $200\231$ s time, the creation of an international Coalition

Against Genocide, the aims of which might include: fostering international coordination in support of regional efforts to enforce anti-genocide measures; providing a forum for high-level deliberations on long-term efforts to prevent genocideln the future; and ensun'ng international support for the i-\201ndings of the OAU Study;
