Based on your electoral mandate, this municipality falls under the governance of the IFP. It is therefore a double pleasure for me to visit and speak to you.

firmly believe in participative governance and partnerships between citizens and their elected representatives. Act No. 5 of 2005 states that we, as traditional leaders, should work closely with municipalities. But it is not only traditional leaders who must have a say in how governance is performed.

Every community member has a right to be heard.

As we approach the May 18" Local Government Elections, much is being

said about your right to voice your opinion through the vote. But | challenge you to consider your vote as more than a right; consider it a responsibility. A great deal of confusion has been sown in our municipalities, particularly in this district of Zululand. Many people seem to have forgotten that the majority of the people of the Zululand Municipal District voted for the IFP as the governing party of the district.

Your vote is being pursued by a new party called the National Freedom Party. They are not the IFP. They are a different version of the IFP. They in fact have nothing to do with us, for the rejected the IFPâ\200\231s philosophy of empowering people towards self-help and self-reliance. They rejected our track record of service delivery. And they rejected the notion of servant leadership, preferring to pursue power and money. | ask you to be vigilant against them and not to buy into the confusion.

| am not here to promote our Mayor. | am here to see whether he carries out the responsibilities which the IFP has entrusted to him. But | will praise him, because | and the leadership of the IFP believe he is the right person for the job in Zululand.

Mayor Gwala is an old war horse. He is an experienced leader of the IFP who has stood the test of time. He was previously a Member of the Legislature in the erstwhile KwaZulu Government and also in the KwaZulu Natal Government after the first democratic elections. He discharged his

responsibilities as Minister with dedication and commitment.

was surprised, when we appointed him to succeed our previous Mayor, that some among you started grumbling; not because of any shortcoming on the part of Mayor Gwala, but because such lies had been told around our previous Mayor that some actually believed she should not have been

promoted out of Zululand.

Ms kaMagwaza-Msibi was deployed by the Party to the KwaZulu Natal Legislature, which is a higher sphere of government. She was promoted. But some trouble-makers, who called themselves $\frac{3200}{234}$ The Friends of $\frac{231}{200}$ tried to make out that she was demoted. | can $\frac{200}{231}$ t understand how they figured that one.

But they carried the lie into the media and even into our communities.

They were of course being copy-cats, because during the Polokwane conflict in the ANC a group of people appeared who called themselves $a\200\234$ The Friends of JZ $a\200\235$, which is an abbreviation of Jacob Zuma. The surprising thing was that, in the case of Mr Zuma, he was in trouble and perhaps needed friends, as he had criminal charges of corruption hanging over his head like the sword of Damocles.

In the case of our previous Mayor, there was nothing that the Party ever did to her. The lies that were peddled that she was being persecuted were manufactured in order to create sympathy as a prelude to her coming out and saying that she wanted to be the President of the Party. Not that there is anything wrong with her wanting to be the President of the Party. The thing she did wrong was to base her intentions on the lie that she was being persecuted.

Nevertheless, her sympathisers, even here in Abaqulusi, could not spell out what form this alleged persecution actually took. No one, even amongst you, can tell us, even now, in what way our previous Mayor was persecuted by the

We knew that our previous Mayor could carry out our directives to serve the people of Zululand. We did not ask you when we appointed her whether you liked her or not. That is why | was surprised that, when we appointed Councillor Gwala to be your Mayor, some people started all these ructions.

| am surprised that people whom | have served with all my heart for so long can suddenly not trust my judgment or the orders of the leadership which they themselves democratically elected. | wonder what difference you have seen in service delivery now that Mayor Gwala has been installed as the Mayor of the Zululand Municipal District?

We are on the eve of the Local Government election. | hope that you will look at my record of service, spanning more than half a century, and decide

honestly whether | have served you well or not.

Most of the schools in this Province were built by myself and the erstwhile IFP

Government of KwaZulu. Many clinics and even some hospitals were built by

me and the KwaZulu Government. Most of the district's roads, which today are neglected, were constructed by me and the KwaZulu Government. Old age pensions were paid for the first time under the KwaZulu Government many decades ago. There were many colleges of education which | and the KwaZulu Government built, which were closed down by the present ANC Government.

As Minister of Economic Affairs, | started Ithala Bank as a facility for poor people to whom commercial banks would not give loans, because they did not have security. Today the Bank has been pillaged by people who should be its trustees, to purchase farms and hotels for themselves and their families. | am surprised that with this track record that stands as a monument there is anyone who could now doubt my judgment when it comes to service delivery.

The Pretoria Apartheid Regime gave us very little money as the Government of KwaZulu, because we rejected independence a /a Pretoria, which was dangled before us by the Regime. We did all the things we did with the little we had, because we are a party of integrity. We respect the taxpayersâ\200\231 money which is entrusted to us, and use it to deliver services to our poor and

suffering people.

It really boggles my mind that all of a sudden people suffer from some kind of amnesia, which makes them forget all these things. Let us not forget how hard the IFP fought to get the vote.

We have Local Government elections on the 18" of May and | appeal to you

to come out in your numbers to cast your vote. Do it for yourselves and do it for posterity. It is vital that all of us come out to vote, particularly because the mischief-makers have now created diversions in an effort to lead you down a

primrose path. Make no mistake, the battle for Abaqulusi is raging.

There are precautions that you need to take to ensure you are not cheated during the forthcoming elections. You should have Party Agents who will be watching that the election is free and fair.

Ever since 1994, during every election that has taken place, there has been a lot of fraud. In this campaign, for example, fraud is alleged to have taken place in Umhlanga, which is a white suburb in Durban. Some busses were

hired to ferry people who live in Umlazi and KwaMashu, to Umhlanga, to

register them as voters for the ANC. We need to ensure that this does not happen here at all.

We must also be vigilant over the Special Vote, which was previously only used in national and provincial elections. Due to the agitation of POPCRU, the law has been amended to allow more people to use the Special Vote

even in Local Government elections.

The Special Vote is supposed to be used only by ailing people, the elderly, pregnant women and others who $a\200\224$ for a good reason $a\200\224$ are unable to go to their polling station on the day of the election. | urge you to look for these people now; list them in your notebooks, so that you can apply for them to

use the Special Vote. Applications for the Special Vote will open on the $15\,\mathrm{"}$ of

April and close again on the 3â\204¢ of May.

| fear that, in this election, we are likely to see more acts of fraud than ever before. We therefore need people who can volunteer as Party Agents.

We have provided training for our Party Agents through our Leadership Institute run by a Member of Parliament, Mr Alfred Mpontshane. Some 80 or so people have already been trained. But this is a drop in the ocean. When | visited some of the polling stations during the voter registration weekends, |

came across many at which there were no IFP Party Agents.

If you fail to volunteer to be Party Agents, you leave yourselves open to a lot of fraud. It is useless for us to cry foul afterwards. Crying over spilt milk will not help us. Let us make sure that Abaqulusi is not taken over by crooks. Use your vote, so that we can get people we can trust to give service delivery, instead of people who indulge in corruption, channelling taxpayersâ\200\231 money into their pockets.

Ever since Mayor Gwala arrived, he has faithfully carried out his responsibilities. Just as \mid did with the previous Mayor, \mid am visiting you today

because my Party is committed to serving you with excellence. To do so, we
