Makgang Mmereki Phologane - Application to Visit Parents in Botswana

Since I write to you for the first time in connection with an application of this sort, allow me to explain for future reference:

Applications to visit Forward Areas (and Botswana is regarded as such) fall under directive of the NEC (1986?)) which prohibits such visits undertaken for private ends. Operational and security circumstances led the NEC to take such decision and I trust it is unnecessary to elaborate. I can only add that deviations from the rule will be partitled only inn exceptional circumstances and a mere desire to see a parent or relation would not ordinarily suffice.

Where permissin to visit a forward area for private purposes is given, travel expenses etc. is to be borne by applicant, making his own arrangement. The principle here is that the ANC does not as a rule pay for missions undertaken for personal satisfaction.

In the application under consideration, it should be allowed taking everything into consideration and I attach letter of endorsement by the Secretary of the PMC.
