Since the beginning of the judicial inquest into the death of an anti-apartheid activist David Webster. evidence presented has exposed the involvement of the government in criminal activities.

The latest revelations by the former Olvll Corporation Bureau (CCB) Col Joe Verster clearly indicate the regimes intention to cover up atrocities committed by members of the CCB.

The court has repeatedly heard that four generals. including the SADF Cheif General Kat Liebenberg, ordered that 003 documents should "Disappear". Yet there is no official response to these shocking revelations. Will these generals simply continue to hold office? There should be futl and tndependet follow-up investigation, conducted by the Goldstone Commission, into all the allegations made In the Webster inquest

Pending the outceme of such investigations, the generals named should be immidiately suspended.
