2. Expected end of the Project situation

The number of students who will benefit by the project is not expected to diminish until 1996 when it is hoped that the political and socio-economic situation will be such as to enable the students to join South African post-secondary and professional institutions. If the political situation changes for a non-racial representative government, the project will end by the end of December 1996 .

3. Target beneficiaries of the project will be South African adolescents who require post-secondary and professional training. The total number of students will be approximately 470 in various fields relevant to the labour market in South Africa.

4. Project strategy and institutional arrangements

The ANC education department is responsible for the selection of the students. The list of names together with the completed UNESCO fellowship application forms are to be submitted to the executing agency by the ANC (S.A.). Placement in the post-secondary and professional training institutions is effected by UNESCO. Payment of the fellowship expenses is effected through the UNDP Office in the African countries or through the administering agency in the countries outside Africa.

Yearly monitoring visits are made to the educational institutions where more than 5 students are enrolled. For countries where less than 5 students are studying, their progress reports are sent to UNESCO so as to obtain the extension of their fellowships whenever needed. The academic progress reports are discussed during the tripartite review meeting.

5. Reasons for assistance from UNDP/UNESCO

The ANC being a national liberation movement has only limited resources. The neighbouring African countries which involved in the fight against Apartheid have always been ready to help the national liberation movement and have in this case agreed to receive the ANC students in their schools.

In the same context of assistance to a national liberation movement, funding is provided by UNDP until such time as peaceful conditions will have been restored at the end of Apartheid in South Africa.

The project contributes to the development of skilled manpower for the country after Apartheid.

UNESCO's assistance is given in the framework of its programme of aid to the African National liberation movement within its field of competence.

6. Special consideration

The beneficiaries of the project are equally divided between boys and girls. The education thus provided to girls will be an important element to be taken into account when the role of these young people in future nation building is considered.

7. Co-ordination arrangements

The project will be executed by the United Nations Educational, Scientific and Cultural Organization (UNESCO) in collaboration with the Organization of African Unity (OAU) under the responsibility of the ANC Dar es Salaam Department of Education. The ANC Department of Education also liaises with the government of the neighbouring states in the Southern region of Africa acting as hosts to ANC adherents. UNESCO Headquarters maintain liaison with the administering agency for countries outside Africa and the UNESCO Education Adviser based in Dar es Salaam also maintains close relation with the ANC and with the host countries' governments and gives assistance in the monitoring and backstopping of the students.

C. DEVELOPMENT OBJECTIVES

Through this project UNDP will help the ANC to provide its members with post-secondary education and professional training, thus enabling them to take part in the development and management of their communities in exile initially and in the future non-racial democratic South Africa thereafter.

D. IMMEDIATE OBJECTIVES OUTPUTS AND ACTIVITIES

1. Immediate objectives '

To extend financial fellowship coverage for the fellows now undergoing academic and professional training through the end of their courses.

To train at least 466 candidates in various fields relevant to the labour market in South Africa. This number is divided as follows : Botswana (2) - Egypt (2) - Kenya (4) - Lesotho (5) - Nigeria (239) - Tanzania (159) - Uganda (50) - United Kingdom (4).

2. Outputs

This project will enable 466 ANC students in various educational institutions in and outside Africa to complete their post-secondary and professional training by the end of December 1996.

Activities

1.1.1. Selection of students by the implementing agency (ANC) in the post-secondary and professional institutions in Southern Africa.

1.1.2. Placement of students by the executing agency (UNESCO) monitoring visits carried out jointly by ANC/UNESCO/UNDP for assessing results of the students once a year and where more than 5 students are enrolled. Students are, in principle, not allowed to repeat at the post-secondary level.

E. INPUTS

1. The ANC : The ANC Department of Education based in Dar es Salaam will be responsible for the initial identification of the candidates who, after approval by the executing agency, will be placed in appropriate training institutions in pursuit of the objectives of this project. The ANC will also collect the progress report of each student for submission to the executing agency. Monitoring visits to each post-secondary and professional institutions where the ANC students are pursuing their studies will be undertaken together with UNDP/UNESCO Offices.

2. UNDP : The UNDP inputs will consist primarily in meeting the cost of fellowships already awarded under ANC/86/002 which will be transferred to this project as from 1 January 1992 and the cost of new fellowship awards. Moreover, other projected courses and training facilities will also be provided for candidates identified by the ANC authorities seeking to improve and reinforce their education.

3. UNESCO : UNESCO will find places in various institutions of training in Tanzania and other African countries. UNESCO will assist the ANC Department of Education in the evaluation, monitoring visits and backstopping of the students.

F. RISKS

The risks involved in implementing the project concern mainly the reduction in the number of beneficiaries due to drop-outs and to repeated failures. Another factor - less serious this one - would be the case of students going back to South Africa in order to pursue their studies in South African post-secondary and professional training institutions.

The regular monitoring exercise is included in the project and regular submission of progress reports should provide information about the trends as they occur and measures could be taken to minimize their effects.

G. PRIOR OBLIGATIONS AND PREREQUISITES :

For the project to operate effectively, it is essential that the student's progress must be followed by the ANC Department of Education and the fellowship application forms duly endorsed by their Education Department. The latter will also inform the executing agency about drop-outs and students' failures. Progress reports should be submitted to UNESCO for the extension of the fellowship award\$. It is understood that without the student's progress report no extension of fellowship will be done.

H. PROJECT REVIEW. REPORTING AND EVALUATION :

1. The project will be subject to tripartite review (joint review by representatives of the ANC, UNESCO and UNDP) at least once every 12 months, the first such meeting to be held within the first 12 months of the start of full implementation. The ANC project co-ordinator and the UNESCO Education Adviser shall prepare and submit at least 3 months before each tripartite review meeting a Project Performance Evaluation Report (PPER), additional PPERs may be requested, if necessary, during the project.

2. A project terminal report will be prepared for consideration at the terminal tripartite review meeting. It shall be prepared in draft form sufficiently in advance to allow review and technical clearance by UNESCO at least four months prior to the terminal tripartite review.

3. The project shall be subject to evaluation 4 months prior to the scheduled termination. The organisation, terms of reference and timing will be decided after consultation between the parties to the project document, plus any associated UN agency.

I. LEGAL CONTEXT :

Since assistance to the project is not provided under the terms of a Standard Basic Assistance Agreement with a recognized government, the following should be noted :

The assistance extended by the United Nations Development Programme (UNDP), to the national liberation movements of South Africa and recognized in its area by the Organisation of African Unity (OAU), is governed by the relevant decision of the Governing Council on the subject. It is of a strictly developmental character and is intended to assist the African National Congress (ANC) of South Africa and the Pan Africanist Congress (PAC) of South Africa, to prepare themselves through proper training of their respective followers, for full and responsible participation in the administration and development of their countries when conditions will have improved sufficiently for them to return there. It takes into account the consideration that beneficiaries sponsored by the NLM's live in

countries of asylum within Africa, that the assisted NLMs' are not sovereign states capable of meeting the full range of counterpart obligations and, in this regard, the stipulation that efficiently and flexibility within the mandate and operational norms and prdbedures of the UNDP are paramount.

The Project Budget

The Project Budget covering the UNDP contribution is shown in the attached budget schedule. By cable MISC 111 dated 22 April 1992, UNDP authorities requested that the budget should be for an initial period of only one year. It is undersgpod that after each tripartite meeting the budget for the next academic year will be agreed between UNDP and ANC.
