1. Minutes of the previous meeting were adopted.

2. Report back on the Bill Siemering meeting.

CHRISTINE

Bill Siemering was involved in the creation of National Public Radio in the US, and in the design of numerous leading public radio programs, especially news magazine, documentary and informal education programs. He was in South Africa making his experience available to people interested in community radio and educational broadcasting. A group of about 20 people turned up to hear Bill speak about educational radio and to listen to a number of taped examples that he brought along. There followed an informal discussion on the different experiences of the participants

3. **TASK GROUPS**

3.1 Policy study:

The sub-committee (Jenny, Nicola, Colin and Roy Williams) did a report on employing international experts to do research.

ACTION#3: KUMI AND NICOLA TO WRITE A LETTER TO THEM .

4.1 The initiative supported CTW in principal - it could have KUMI training and educational value for South Africa. The letter should emphasise that the initiative cannot be rushed and that the pace should be decided upon by the EME.

If a researcher comes to SA for 6 months, they must link up with the EME so that the EME can guide and benefit from the research.

5. LOBBYING LETTER #2 SABC BOARD

The letter wasn't sent to Wynand Harmse. It was agreed that we should not approach the SABC management until the SABC board issue is resolved. Then a submission to the board should be made.

ACTION #4: NICOLA WILL RE-DRAFT THE LETTER AND SEND IT WITH DOCUMENTATION.

5.1. Explanation of why IFEE suspended negotiations with the SABC. BARRY EME reiterated support for IFEE and voter education initiative.

ACTION #5: CHRISTINE WILL GET A COMPLETE LIST OF NAMES AND ADDRESSES OF SABC BOARD MEMBERS.

6. There is concern that the political profile of the EME is not KUMI broad enough. NEC organisations must be contacted and encouraged to take part in the Steering Committee meetings.

ACTION # 6: DESMOND WILL DRAFT A LETTER TO BE SENT OUT.

9. Report on the IBA. **NICOLA**
- 9.1 John has a document on Human Rights and Broadcasting which can be used as a base document for a submission to the Technical Committee, which will then give a report to the Multi-Party Forum. The EME must monitor the work of the Technical Committee to see when a more forceful, thorough document can be sent. **JOHN**
