

Please be advised of the visit of Jouni Koskinen of VLTL to
Dakawa to discuss continued support for the Health Centre there.

VLTL is the Finnish Union of Employees in State Enterprises and has already supplied the Centre with an ambulance and medicines.

Jouni arrives on Friday 20th April, Swissair 06.25am, and will call at the Dar Office to arrange for transport to Dakawa or Mazimbu, depending on where he is accommodated. Marjatta Lahti, currently in Finland, informs she is likely to be in Dar over this particular weekend and is willing to assist in this regard.

This visit has been approved by the Health Secretariate at HQ, which also informs that Dr. Pren Naicker from the Secretariate has been delegated to participate in discussions starting on the 23rd of April. It is envisaged the visit will last 3-4 days, giving our guest time to also acquaint himself with the overall development of Mazimbu and Dakawa. He will be writing a report for all the members of his Union and we hope a suitable program can be arranged. It would be appreciated too if a member of the photolab could be on hand to provide photographs.

The Dar Office has been telexed(copy enclosed) all passport details for the necessary clearance to both Mazimbu and Dakawa for the period 21/4 - 27/4/90, although he will most likely complete his mission before the 27th.

re: VLTL/Jouni Koskinen visit to Mazimbu/Dakawa 23-26 April 1990

VLTL is very dissatisfied with the outcome of the above trip. According to Koskinen, he was only allowed into Mazimbu on Wednesday(he arrived in Morogoro on Sunday) and only a short visit to Dakawa - "one hour" - was arranged to get acquainted with their project. They feel, given the time and expense involved, that the visit not very productive.

I would appreciate some clarification as to precisely what went wrong, given the fact that all relevant departments were timeously and adequately informed of the visit and its purpose.

In the meantime, VLTL has agreed to purchase goods for the Dakawa Clinic during 1990 to the value of 70 000 Finnish Marks(16 000 USD). They stipulate that our list should not include any drugs(they are aware of Finnida's role in this regard), neither are they in a position to supply another ambulance or a motor vehicle. Matters would be greatly facilitated if the list reaches this office before the end of August.

The drugs they have already ordered based on previous lists will be shipped in August/September this year.

Re: VLTL visit to East Africa

Apologies for delay in reply to your letter dated 12.06.90. Being the one who met with comrade Koskinen, the Health Secretariat though it best for me to give you a report upon my return. I only returned from various other missions abroad a few days ago.

I must say that I was very embarrassed to find that comrade Koskinen's clearence was "sabotaged" by a local PRO officer in Mazimbu. There is a long complicated story to this which I will not go into in this letter.

Except, to say that the clearances for both comrade Koskinen and the Finnida Consultant (whose arrangements to visit Mazimbu and Dakawa were made separately and without the knowledge of the Health Secretariat) had to eventually be processed by the Chief Rep. himself. You will understand I was not in a position to explain these details to the visitors.

I however did try my best to make them both comfortable and draw up a visit programme with our head of the East Africa regional health team, comrade Jimmy Mabaso.

To my suprise I learned from your letter that the VLTL has now changed its mind about using the USD 16,000.00 allocated for 1990 on an ambulance. We had agreed with comrade Koskinen on this and we even talked of processing a proforma through your office. Similarly, the same approach was agreed with the Finnida Consultant viz. that we could purchase drugs and lab equipment (if available) in Tanzania through processing a proforma from the medical storesthere. I'm now made to understand that Finnida wants to purchase all items in Finland. Is this true? Then why had the Finnida Consultant in Tanzania misinformed me?

Anyway, I did apologise for all the inconveniences caused and on their departure, I was left with the distinct impression that their visit was a success.

About comrade Koskinen's visit to Dakawa being short, I suppose there's not much to see in terms of our clinic there. Its small. This part was handled totally by comrade Jimmy Mabaso.

Frankly, I dont remember hearing any complaints after the visit. Please convey our apologies once again.


