## International links:

The NSC recognises that the route to international sport is through Africa on recommendations by SOuth Africans themselves. The NSC has, accordingly, approached Sam RamsamyJOf SAN-ROC to be their representative abroad. His role is intended to Complement our efforts and set up the infrastructure without which our goal to be eventually part of the sporting community of nations cannot be realised. His role is also to open doors for our sportspersons in accordance with the needs of South African sports people as a whole. Sports develOpment and technical assistance are presently urgent tasks on the NSC agenda, particularly in light of the current imbalances between establishment sport and non-racial sport.

In the southern African context, this country falls within Zone 6 \_of the Association of National Olympic Committees of Africa (ANOCA). Through SAN-ROC, the NSC has established cordial relationships with the President of Zone 6, Mr Tommy Sithoie and the Secretary General, Mr Ismail Bhanjee. At their Mauritius meeting last year, the Supreme Council for Sport in Africa (SCOA) authorised its secretariat to grant "appropriate" recognition to the NSC, which was at its interim stage then. We expect this relationship to be developed now that the NSC is fully inaugurated. We have now established contacts with many organisations in various arts of the w a pathetic understanding as our aims and intentions are compatible iwith those of the-international community.

Overtures to establishment sqort:

The NSC is not driven by malice and a desire to hit back at those who have benefited -from aparthei d. We believe that non- -racial sport has higher ideals and therefore we need to seize any and all initiatives. The test we use to analyse the correctness of a position is whether it will advance or retard our cause i n establishment of a non raci al sports structure in a democratic nonracial society. We look faVOurably at actions which will advance our cause and unfavourably at those which will retard it. We prefer to advance our cause while simultaneously eroding racism. We, accordingly, subscribe to the notion of two South Africas - thus identifying apartheid as the main cause of the South Africa sports problem. In terms of this notion apartheid which has badly splintered sport and has caused South Africa's exclusion from international sport, divides the ceuntry into pro- -apartheid and anti apartheid camps. The NSC believes in a strategy of simultaneously consolidating the fragmentation within the antiapartheid camp whilst "reaching Out" to establishment sport. We believe that our cause is so strong that we are likely to succeed in overcoming opportunism and expedience.

We must also emphasise our seriousness about this country's sports programme. Journeymen, therefore, have no place in our set up. We

Protests Acaihst International Soorts Ex Czanggg; T116 disadvantaged section of South Afr can sport has always been age inst South Africa, or shall we 53 ay white South Africa participating in international sport. However, wide-spread overt international protests have not taken place in the past. This increased the confidence and arrogance of white establishment sport which, in turn, ebowed little or no respect For hlank spnrt The founding of the NSC reversed those trends. In 1989 the NSC organised pilot demonstrations against the touring i? ternational rugb; team invited by the South : African RJ-gby Board. In January and February of this year the NSC mobilised country-wide demonstrations against the so-called English rebel cricket team invited to tour our country by the establi.shmer t South African Crlcxet Union. The demonstrations a:ainst tLe t ur were report :h:OLghoet the w rlA. The success of the NSC mobili setion resulte: .1: tie tour be' ng -rematurely terminated. The term ination of the :Our was historic in that such a thing hed never be appened he- ore. h rtheid sports tours were, at last, effectively Ccuntered in t.he nt:y 1t3clf.51nce then there have been :cvc- al uthez e tions; and threa ts of NBC demonstrations have aborted hterhatLloral sports exchaeges by establ115hment sport. Only recently ehl RSC succeeded in obtaining an assurance from the erganisers 01 the Sun Clty Xlllioe Dollar Intel national Golf Classic that they would abide by our call for a sports  ${\tt mOlatorium}$ on international exchanges.

## Reaching out:

Accusations against NSC over tu res to establishment sport are mostly emotive. Charges include Mt temcnts 111.3 "mhesc pe-plc (Whites) have a hie- cry of dishonest ty" or "What are they giving up in the unification process?" Our ans swer is th hat we have no permanent enemiee - we would be excluding a fair pr Oportion of our country'; population if we did.

## Jni ty .NSPOIt:

the NSC, since inauguration and even .-ihen it was operating as an 1hter1w committee, has campaigned vigoro ously for unity in sport as a pre- regulsite for international recoq griti\_on. We have crested several forums out of which dissussions on 590 orts unity have beEUh and are proceeding satisfactorily.

any establishment organiations ere :19w snowing great en husiasm for unity. The NSC is playing t e role of the honest brener 1n reating the appropriate platfo rms for unity.

## Snorts Charter:

The NSC has decided to launch a massive information gathering campaign where they will be asking sports people right down to player level to speak up and say what is needed to be reflected in NSC Policy Guidelines. This is to be achieved through a multipronged approach through a coordinating committee, an affiliate's forum and a call for input from the rank and file, over the next few months. The outcome of the campaign is-going to be a aOCument referred to as a Sports Charter which will be used to guide the organisation through its present course towards a truly mass-based sports movement based on nonuracialism, fair play and justice, and sport for all.

The NSC, at its meeting on 20 October 1990, agreed to set uh r  ${\tt a}$ 

three-way task force, i.e. the NSC, SAN-ROC and SANOC, to investigate the feasibility of esta lishing a single Olympic body in South Africa. This meeting also set up a structure elected personnel who will liaise with other organisations and will, 3n behalf of the NSC, oversee the establishment of the new Olympic bcdy.
