supports the choice of theme for the 1990 conference, which is "Different Voices : Language, Culture, Identity.";

supports the educational principles underlying this choice of theme which recognises the right of each student to an education which respects his or her potential regardless of race, creed, gender or nationality;

acknowledges that the government's apartheid policies in South Africa deny students an education based on these principles;

therefore does not at present support attendance by residents of South Africa at the 1990 IFTE Conference."

This policy is consistent with the resolution adopted by the 1985 Nassau agreement of the Commonwealth Heads of Government.

This agreement, as you will be aware, discourages participation involving South Africans in cultural and scientific events except where these contribute to the ending of apartheid, or have no possible role in promoting it.

We are aware, however, that there are arguments to support a "selective boycott" of South African citizens, so that those working for the mass democratic movement inside South Africa can be supported by attendance at international conferences. We are also aware of arguments to support an "academic boycott" of all South African residents in the interests of bringing about equality for all the peoples of South Africa by placing pressure on the South African government.

We should be grateful if you could let us know whether the African National Congress supports either a selective boycott or a total academic boycott of South African residents at international conferences such as the one proposed in Auckland in 1990.

"selective boycott", have you any advice for us on procedures we should adopt to ensure that South African residents who might apply to attend the conference can be identified as genuine opponents of the South African Government's apartheid policies?
