

Re: LATE MISS LINDA KALUWA ZULU

My daughter Linda died at Elim Hospital near Louis Tritchardt in RSA on 1st June, 1993. The facts are as follows:-

- (i) My daughter was a family friend of Wiseman (an ANC Freedom Fighter) and his wife Emilia an Angolan. They lived in the Berea Area in Johanesburg at Telephone No. 643-8886.
- (ii) Before Wiseman and his wife Emilia returned to RSA on return of ANC Exiles they lived in Lusaka at Hellen Kaunda which is about two kilometres from my house in Kudu Road, Kabulonga. Although I did not know the family myself my wife and my daughter Linda knew them as Linda on several occasions used to baby-sit and took care of their small child when they went out in the evenings.
- (iii) In December, 1992 Linda went to Johanssburg to visit her aunt Mrs. Edith Kabwe and discovered that Wiseman and Emilia lived near Mrs. Kabwe.
- (iv) At the beginning of May, 1993 Wiseman and Emilia invited Linda to stay with them for a short time and she lived with them up to 12th May, 1993.
- (v) On 12th May, 1993 Linda visited her aunt Mrs. Kabwe until 2200 hours and informed her that Wiseman had arranged Airtickets for Linda to go to Harare in a group of ANC on Sunday 16th May, she would then travel to Lusaka by road.
- (vi) Unknown to Mrs. Kabwe and Linda's uncle a Mr. Nyondo, Linda was taken by road on the night of 12th May by Wiseman and perhaps other people unknown but wiseman telephoned to his wife on Thursday from some border that Linda had on the way become mad and was violent and had injured herself. He did not disclose from which border he was telephoning.

Consequently Mrs. Kabwe set out to find Linda without success and came to Lusaka. My wife also went to Mafeking via Botswana searched for her at the Hospital with the help of the Police, failed to find her and she returned to Lusaka.

- (vii) A kind lady from Zimbabwe telephoned me to tell me that Linda was at Elim Hospital and my wife left for that place and arrived on Monday 31st May to find Linda was at the point of death. She was not able to speak or eat and she passed away on the following day on 1st June.
- (viii) I drove to Elim on 2nd June and returned with Linda's body on 9th June and we buried her at Leopard's Hill in Lusaka on 10th June.

My investigations reveal the following: -

- (a) On Saturday 5th June I called at Messina Hospital where I was informed that Linda was admitted at that Hospital for one night on 12th May she was violent and they had to give her Lagactil to relieve pain and valium for sedation.
- (b) I then called on Messina Police who informed me that Linda was handed to them by an ANC family friend who was driving a Kombi and said they were on the way to Harare but Linda went mad en-route and he thought she had taken Mandrax. They then took her to Messina Hospital where she tried to jump out of the window and sustained a deep cut on the left leg. On 13th May they fetched her from Messina Hospital and took her to Louis Tritchardt Prison because she had over stayed in South Africa.
- (c) I then went to Louis Tritchardt Prison where I saw the Prison Superintendent and a Prison Nurse Miss Muller. The Prison Superintendent told me that Linda was shivering and she had very high temperature she was ill and he drove her to Elim Hospital on 18th May. Miss Muller told me that Linda told her that on the way someone forced tablets down her throat which she thought was Mandrax and they tried to set fire to the Kombi where she was a passenger with intention of killing

Which she thought was Mandrax and they tried to set like to the Kombi where she was a passenger with intention of killing her but she clung to one man which saved her. Linda repeated this story to the Zimbabwean lady who had been with her in Prison and who telephoned me from Harare.

(d) At Elim Hospital Linda was admitted under Intensive Care of three Doctors who carried out tests for Malaria, typhoid, blood and other tests which were negative. They still treated her for Malaria and typhoid and gave her a very strong anti-biotic but her body temperature was still very high. She continued shivering, she was unable to speak and eat and just when they were about to transfer her to Pretoria Hospital she died on 1st June of Cardio Pulmonary arrest. The Doctors therefore failed to diagnose the foreign agent in her body which was causing very high body temperature. Of course they did not know that she may have been given drugs.

The purpose of approaching you Sir, is to kindly request you to cause your Organisation the ANC to investigate the conduct of their Soldier Wiseman. Perhaps they can shade light on the circumstances leading to the sudden apparent insanity of Linda between Johanesburg and Messina.

Your early action shall be greatly appreciated.
