I am honoured and delighted that you have agreed to address the Mega Plastics Group at our Annual Reportback on Friday 15 October 1993 at the Eskom Conferenca and Exhibition Centre in Midrand. The scheduled time of your address will be 15:20 for about 45 minutes.
