NPA Tanzania has informed ANC that they will recommend to Ministry
of Foreign Affairs the following actions required with reference
to NPA's impressions from the Donors Conference in Arusha.

1. ANC to produce documentation in order to improve the present
shortage of qualified administrative and technical ANC personnel
in Dakawa (PMU Workshop recommendation February 1990).
2. ANC to produce a realistic revision of the revised 1984
Development Plan.
3. ANC to give priorities within the revised plan, item 2 refers.
4. ANC to immediately give priority to fund raising and donor
relationship for Dakawa (item 2 and 3 refers)
5. ANC to concentrate a future development of Dakawa to VTC
Development, Secondary School Development and Agriculture.

These Developments must be corresponding with donors contributions based on impressions experienced in the Donors Conference.

6. Immediately actions to above items should be taken by MC.

NPA's opinion has been expressed to ambassador G. Gorbo in a meeting in Dar es Salaam 13/2/91 and to African National Congress's .Director of Projects Cde H. Tikly in a meeting in Dar es Salaam 17/2/91

NPA Dar es Salaam has been given a copy of ambassador G.Garbo's document no.27 dated 12/2/91 addressed to Ministry of Foreign Affairs, and we await Hr. Bjorn Lunle's comprehensive report from the conference.
