PROPOSALS FOR AND EVIDENCE IN SUPPORT OF;

1. THE RETENTION OF EAST GRIQUALAND AS PART OF THE
NATAL/KWA ZULU REGION

INTRODUCTION

This submission, prepared by the Borough of Matatiele after consultation with the residents of the area, seeks to establish that the area of East Griqualand, Mount Currie, meets with the Criteria to remain in Natal/Kwa Zulu.

No evidence or Criteria which led the Commission to place East Griqualand in the Eastern Cape/Kei Region could be substantiated, bar the fact that the recommendation of the Commission to the Negotiating Council could have only been made to appease and reward certain Politicians for previous favours.

However, this has led to the people of the area making their voice heard which should in fact have happened in the first instance to make evidence available that satisfies all the Criteria necessary for inclusion in Natal/Kwa Zulu.

HISTORICAL BOUNDARIES

The Boundaries have been dealt with in the East
Griqualand Regional Development Associations

submission prepared by Messrs Conningarth Consultants, which the Borough of Matatiele supports.

We also recommend that the Commission refer to the

"Steyn" report dealing with the Incorporation of East Griqualand into Natal, dated October 1976.

ADMINISTRATIVE CONSIDERATIONS

Matatiele (East Griqualand) is some 260km from Pietermaritzburg and 50km from East London and even further from Port Elizabeth.

Administration efficiency would diminish as was the case when East Griqualand formed part of the Cape Province. Administration in East Griqualand would continue to enjoy the ease and efficiency it has since its 1977/78 incorporation into Natal.

The following Administrative functions will be better served by Natal than the Eastern Cape Region.

Judicial and Legal

The Seat of the Supreme Court and Master of the Supreme Court for estate purposes, Deeds Office, Surveyor Generals Office, Attorneys, Attorney General and Magistrates would be able to serve the People better being only 260km away as apposed to distances compared with East London, Port Elizabeth and Umtata.

Fiscal and Financial

The Receiver of Revenue in Pietermaritzburg almost operates efficiently, however, it is convenient for People in this area to travel to Pietermaritzburg and resolve their Tax problems and Bueries at a reasonable cost to them.

Should this important function be moved to East London or elsewhere, the cost of resolving problems will be exorbitant.

This will lead to frustration amongst Businesses and will not encourage and promote Business initiative.
Health and Welfare

To have this function removed from the People will be disastrous.

The elderly People must have their Regional Office close to them in order to have their problems resolved. Pension Payments will become an increasingly difficult task to monitor and control.

Education

Defence, Security and Policing

Transport, Post and Communications

This matter is a great concern to this area as the Roads Network leaves much to be desired. The Roads Surfaces are unacceptable for the Free Flow of Traffic. Incidents of violence on the main Routes from East Griqualand to the Eastern Cape will complicate matters should People wish to travel to Fort Elizabeth to resolve their Tax, Pensions, Housing, Educational and Legal Problems.

The element of violence and undesirable incidents on these Routes must be highlighted as the safety of our People in this Region is of paramount importance to us.

Agriculture, Water Affairs and Veterinary Services

Customs and Excise

Community Development

Provincial Services

Correctional and Prison Services

Housing

Seat of Government

The clearer these functions are to the people the more efficient they will operate.

COST EFFECTIVENESS

All the factors mentioned in FParagraph 2 Sub

Paragraphs 1 - 13 above contribute to the containment of Costs through efficiency, ease of access, better communication and more effective Government close to the People.

This together with cheaper service provision to the People makes economic sense to incorporate East Griqualand into Natal/Kwa Zulu.

MINIMISE INCONVENIENCE TO THE PEOPLE

This aspect is satisfied by maintaining the STATUS-Quo.

To remove East Griqualand from Natal will cause

not only INCONVENIENCE but communication problems eg. Roads, Post and Telecommunications. The Road network and infrastructure leaves much to be desired and will result in long delays and an Administrative disaster, ultimately resulting in the break down of Government control and efficiency.

To remove Government away from the People is like taking the air away one breathes, which results in death. One does not want to see a successful system deteriorate into a costly ineffective type system put in place to meet a Political compromise, rather than taking the interests of the Community of an area into Consideration.

ECONOMIC VIABILITY

The East Griqualand district is Economically viable and has even more potential should sections of the Northern Transkei (Ongeluksnek) ((Umzimkulu) be included in a Natal/Kwa Zulu Region The whole area is very dependant on Natal. Durban and Pietermaritzburg are the dominant economic Cities influencing the Region. Should these areas be allowed to develop within a Natal Region it is anticipated that job-creation and poverty could be addressed within a reasonable time. However, should this not be the case unemployment and poverty will remain with us as a cancer, eating away little by little.

However, should the negotiating Council be serious about addressing the Socio\200\224-Economic needs of the people then they will incorporate both East Griqualand

and Umzimkulu into the Natal Region.

EMPLOYMENT AND JOB OPPORTUNITIES

Residents from the Matatiele and Surrounding Areas all look towards the Reef and Natal for employment.

However, as East Griqualand cannot form part of a Transvaal Region it goes without saying that it must be incorporated into Natal.

Language and Culture has always been a point of debate. However, in a new South Africa we have all been called to respect each others Culture and Language, this we do. However, we also realize that this debate must not be used against the interests of the Region for Political gain by Committees, Negotiators, not sensitive to the needs of the people of the Region.

RECOMMENDATIONS

That East Griqualand be demarcated as part of the Region Natal/Kwa Zulu.

That the Mt Currie district of East Griqualand and Umzimkulu are in every respect indivisible and should as an entity form part of the Region Natal/Kwa Zulu.

Matatiele is not opposed to other Northern Transkei Committees making representation, to also be incorporated in Natal /Kwa Zulu.

Attached are copies of 1132 signatories to a petition supporting E 6 to remain part of Natal/Kwa Zulu.

Finally, should the Commission decide to reaffirm its previously stated view, that East Griqualand

be incorporated into an Eastern Cape/Kei Region then the people of East Griqualand and surrounding areas demand that a referendum be held to determine the wishes of the People. That the Commission and the negotiating Council accept full responsibility for the consequences which may occur when the Regions are finalized and East Griqualand and Umzimkulu is

not part of Natal/Kwa Zulu.

CONCLUSION

The Matatiele Councillors and Local Affairs Committee Members thank the Members of the Commission for coming to Kokstad to hear our submission and urge the Commission to give careful Consideration to the contents of its submission and take into account

the feelings of the People of the Region and

not to pursue preâ\200\224conceived ideas in fulfilling Political aspirations, as dictated by certain Politicians.

We have full confidence in the integrity of the Commission to act accordingly without outside Folitical influence.
