One of the aims of the LSE Debating Union is to provide a platform for views

. and causes which are denied an adequate hearing in the commercial media. This

year we intend concentrating on the struggle of the people of South Africa. To this end we are organising, in consultation with Cde Mompoti, a major campaign in the schools and universities in and around London to mobilise students against apartheid and to politicize them as to its effect on the whole of Southern Africa.

To launch the campaign we are planning a major series of public evening debates on the issue, to which the media, parliamentarians, businessmen and students will specifically be invited. We are keen that the A.N.C. should be represented at the highest level on at least one of these occasions and, accordingly, we would be delighted if you were to accept an invitation to debate at the London School of Economics.

The motion we would suggest is that "Only Socialism can satisfy South Africa's future"â\200\235, but we would be happy to agree to any other motion you might consider to be more constructive. Were you to agree to this suggested motion, we would endeavour to persuade Harry Oppenheimer, Gavin Relf or Mike Rosholt to fly out and Oppose the motion.

We would ask you to deliver a speech of approximately 20-25 minutes. The Opposer would then do likewise and the debate would then be thrown open to the floor. In conclusion, each speaker would have 5â\200\22410 minutes to sum up before moving to a vote.
