Thank you for your fax dated 16/12/91. We are pleased that the NOD Committee will give its response after its meeting on 6/1/92. Since the ANC had earmarked projects inside S.A. as beneficiaries of the balance of NOD funds, they have built up expectations and will be happy to know the outcome of your discussions.

May I point out that we have not requested funds for salaries externally from NOD. The salary request was made to DINIDA. I refer to paragraph 3 of your fax.

Herewith please find my Preliminary Report following my visit to Tanzania for December 17-24, 1991. I am posting a copy to the Reverend Christian Balslev-Olesen in Harare but I understand he is with you presently in Denmark. Further information about Mazimbu and Dakawa will be sent to you as soon as it is available.

Please accept my belated seasonal greetings.

PRELIMINARY REPORT ON MAZIMBU AND DAKAWA

The NEC-Commissioned Inter-Departmental Delegation (also known as the TASK FORCE) visited Tanzania from December 10th to 24th, 1991. Its mandate was to review winding-up arrangements in the light of the ANC's decision to phase out from and handover Mazimbu and Dakawa to the Tanzanian Government by mid-1992, instead of the earlier phasing out period of between two to five years.

Extensive consultations were held in Tanzania with all relevant ANC structures and personnel and with some donors and donor agencies, such as TCRS.

The Report and Recommendations of the Inter-Departmental Delegation will be submitted to the NEC in early January and it is anticipated that the ANC will issue a statement on Mazimbu and Dakawa during the third week of January 1992.

Due to the delay in the Inter-Departmental Delegation's visit to Tanzania, it was not possible to submit documentation to Danchurchaid, as mentioned in the Reverend Christian Balslev-Olesen's SUMMARY OF DECISIONS BETWEEN ANC, TCRS, DCA, dated 30/11/91.

Meanwhile, we would like to endorse the budget for the completion of construction works of NOD-sponsored projects. This budget was submitted to the Reverend Balslev-Olesen on the 28th November, 1991. This is in line with the ANC decision to leave Mazimbu and Dakawa in a functional state.

Kindly clarify what the exact balance is of NOD funds, taking into account the amount of USD 171,000, identified by TCRS and the USD 250,000 earmarked for external use from the balance of USD 1 million as indicated to us by Danchurchaid. In other words, please let us know exactly how much is available in total externally, after deducting the USD 113,842 budgetted for the completion of construction works at Dakawa.

The Proposal for the utilisation of the DANIDA balance of DKR 2.7 million, as reflected in the above-mentioned document is under discussion in Johannesburg and our response will be sent to you as soon as possible.

We await DANIDA's response on the Salary Budget Proposal and will present in January a revised budget for a smaller core of ANC personnel who will remain for winding-up and maintenance tasks. We place priority on this as it will enable a smooth transition period and provide the basis for continuation under Tanzanian management.

Finally, we appreciate your visit to Mazimbu and Dakawa from November 26th to 29th, 1991, in connection with DANIDA and NOD Programmes.
