In the meantime we need, urgently, another bridging loan of say \$30 000 - &50 000 from Christian Aid, if they will. We have good reason to expect funds within the next ten days from a major donor, but we need a bridging loan urgently. The donor gave the undertaking to us in Mr Mandela's office, with Mandela in the chair, last Friday.

SIDA will continue funding us at the present level during the 1991/92 academic year. Their next cheque to us (9120 000) is due here in January 1992.
