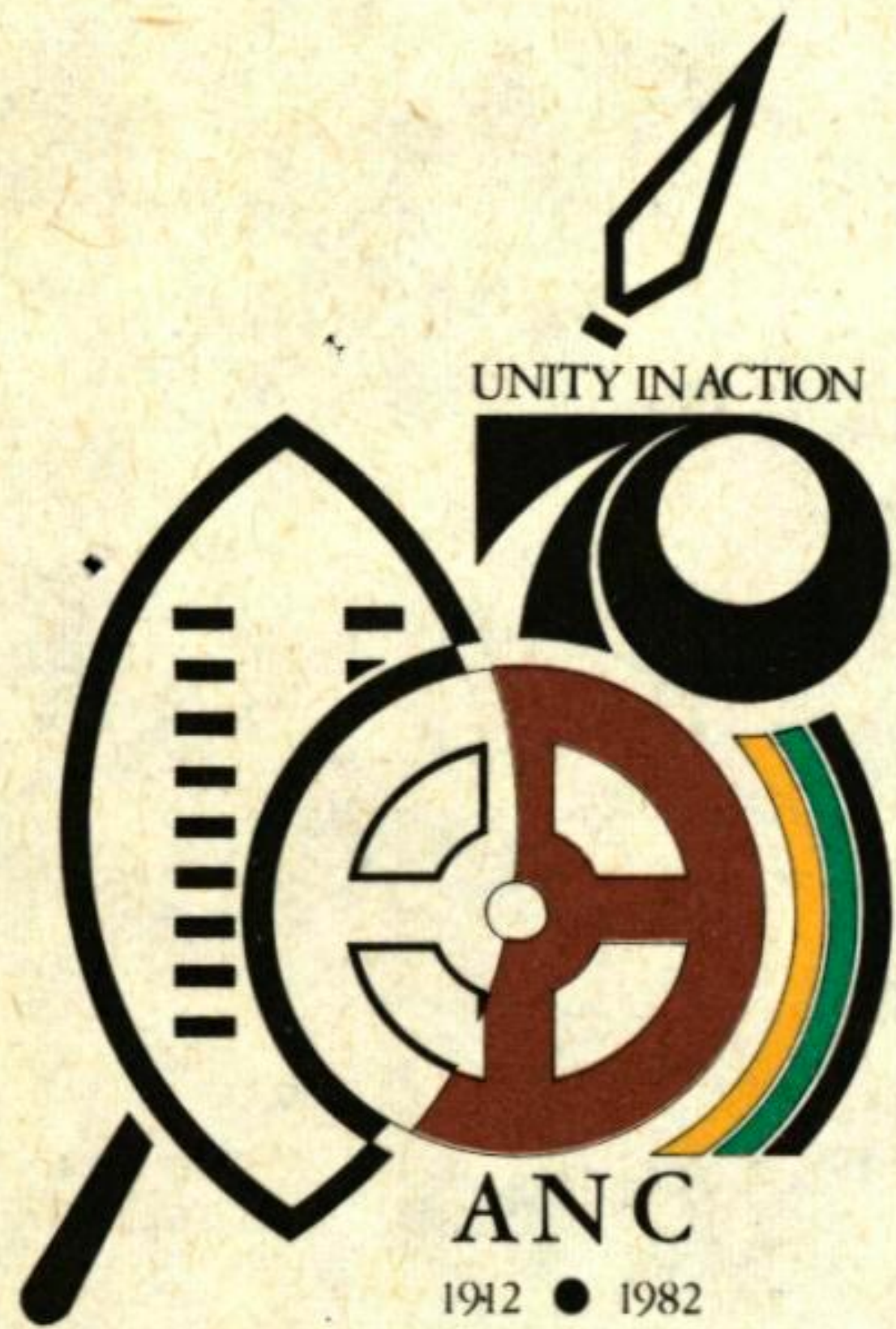

I had hoped that the confusion would have been cleared up by now, but until Friday I had not heard from you or Dulcie who was going to clear the matter with you.

A decision had been taken at headquarters that Vernett should travel to Lusaka and is expected to be there for some considerable time. Cd. Thomas did OK the tkt., some time back, what I would like to know from you is whether we should obtain the tkt from here or you will arrange a PTA.

It is important that Vernett travels direct to Lusaka. His state of hyperexcitability, which could be brought on by travel via Moscow (on Aeroflot), would result in a number of problems. His state is steady at the present time, it is, however, advisable that he travels to Lusaka, direct. This matter has been discussed in the office with the Chief Rep., who is of the same opinion.

Cd. Albert who is here to have his travel document extended, has been allocated with funds for the purchase of a variety of items for the Chongela farm. 
Purpose of meeting: Further assistance for SMFC from NOVIB, and the priorities for SMFC.
