



The following reports have been received today:

ANC PWV REGION REPORTS:

Twenty-one people were hacked and shot dead on the night of the 17/06/92, when armed men from the KwaMadala Hostel, allegedly dropped off by police casspirs, randomly attacked residents in Boiphatong and the nearby Slovo informal settlement camp. It was also reported that property was looted.

PEACE ACTION REPORTS:

17/08/92

- 1. 7.30pm first call received from Sebokeng, Zone 11. Caller expressing concerns of pending attack, after another resident had received a telephone call saying "don't use your car, there's going to be trouble". The caller had difficulty getting any positive reaction from the police in his area and therefore called Peace Action.
- 2. 2nd call received from Vaal area. Caller saying that she had been tipped off by somebody that had been told by the white counterparts of Inkatha that "the ambulances must be on standby. They are going to be used."
- 7.44pm Col. Gouws from the Witwatersrand division returned monitor's call.
 Monitor reported above calls to him, gave him first caller's name and telephone.
 He said he would take over the matter.

18/08/92

- 4. 4.00 am caller reported attack, that police were teargassing the residents, general chaos in area.
- 4.31 am call received that about 50 people had been killed and that inkatha was brought in with police casspirs. And some attackers were on foot.
- 6. 4.53 am 2nd caller (no.2 above) telephoned again, reporting deaths and injuries.
- 7. 6.40 am call reporting deaths and injuries was received.
- 8. 7.02 am Col. Gouws reported to monitor that security forces were having difficulty in entering the townheip and had to go in armoured vehicles.

- 9. 7.50 am first caller (no.1 above) confirmed that police had contacted him last night.
- 10. 10.00em caller reported that police in casspirs moving around and shooting residents. Police confirmed, saying that they were returning fire at residents that were shooting at them.
- 11. At 10.30am 2nd caller (no.2 above) telephoned again. Reported that police were at hospital and it was suspected that they may remove bodies to reduce the death toll.

RADIO REPORT:

Radio 702 reported at 1.00pm on the 18/06/92 that the death toll now stands at 34.

HRC COMMENT:

This horrifying massacre confirms that there are elements within Inkatha and the Security Forces that have an interest in fuelling the violence anf fulfilling their own prophecy that the ANC's programme of Mass Action will raise the political temperature. The lives of people are as nothing to them in this criminal game of destabilisation.

DEATHS AND INJURIES

- " The death toll in May was 296, a drop for the second consecutive month, from 437 in March and 356 in April. Average daily death rate has declined from 14,1 in March to 11,9 in April to 9,5 in May. Deaths for the year 1992 now total 1433 which is 22% more then at this time last year.
- " Injuries for the year total 2536, or 38% ahead of last year.

SOURCES

- Vigilante-related actions accounted for 228 deaths (or 77% of the total) and for 191 injuries (70% of the total).
- * Security Forces were responsible for 20 deaths, the highest figure in over a year, and for 40 injunies. They themselves suffered an increasing level of casualties (15 dead and 26 injured in 36 attacks).
- " Hit Squads claimed 3 victims this month, bringing the total for the year to 36.

AREA ANALYSIS

- * The PWV area was again the hardest hit with 208 deaths (70% of the country total) and 192 injuries (also 70%). The Vaal took over as the major fashpoint (74 deaths), while Soweto (56), East Panc (45) and Alexandra (23) all showed siginificant decreases.
- " Natal continued to maintain a remarkably constant level of deaths with 79 for May, or 27% of the country total. South Coast escalated with 41, Midlands stayed at 22, while Durban (9) and North Coast (5) abated substantially.
- · Other areas accounted for 9 deaths, or 3% of the total.

VICTIMS

- * Commuters (on trains, buses and taxis) again came in for attack during May. In 31 incidents there were 36 ceaths and 41 injuries. Of these, train attacks accounted for 23 incidents, 23 deaths and 24 injuries; bringing the total for the year to 175 incidents, 168 deaths and 312 injuries.
- * Women and children continue to be amongst the casualties. Women suffered 25 deaths (8.4% of the total) and 28 injuries (10%), while 19 children were injured.
- " Where the affiliation or location of the victims within the community could be assessed from reports, (in about 30% of all cases), the following emerged in May:

ANC supporters and township residents - 90% of the dead, 86% of the injured. Inkatha supporters and hostel dwellers - 10% of the dead, 14% of the injured.

(Ratio of 9 to 1 and 5 to 1)

ATTACKERS

Where the attitiation of attackers (other than Security Forces) could be assessed from reports, the following emerged during May :-

ANC supporters and township residents - 3 attacks resulting in 7 deaths and 4 injuries. inkatha supporters and hostel dwellers - 2: attacks resulting in 2: deaths and 49 injuries.

REPRESSIVE LEGISLATION

At the end of May, Unrest Area declarations were in effect in 13 PWV townships, 58 townships in the Pletermarkzburg district and in the Flohmond magisterial district.

DETENTION WITHOUT TRIAL

During May a further 30 persons were detained without trial, but only 1 person was still being held at the month' end. Detentions for the year have now topped the 100 mark, without about half in Bophuthatswana and Ciskei, and almost half under the notorious Section 29 of the ISA.

DEATHS IN POLICE CUSTODY

Two deaths in police custody were recorded this month.

POLITICAL ARRESTS

Security Forces made 787 political arrests during May. Of these, 72% were identified with protest action around two issues:

416 Teachers and scholars demonstrating about educational issues.

154 women demonstrating about the presence and behaviour of security forces in the Pietermaritzburg area.

POLITICAL TRIALS AND IMPRISONMENT

HRC recorded 25 political trials as having been completed in May, involving 732 accused and resulting in 58 convictions, but only 1 person being imprisoned.

" As at the end of May, there were still 111 political trials in progress, involving 1640 accused.

- " A feature of political trials this year has been the high number of persons per trial, about 16, compared with about 6 during 1991. This is an indication of the target focus moving away from individuals or small groups towards mass "Megal demonstrations".
- From information received during May, the HRC has been able to delete a number of names from its tist of Political Prisoners. The list now ocmprises 353 names.

DEATH ROW

Three more deaths sentences were harded down in May. Current number on death row is 297, including 8 politicals.

BANNING OF GATHERINGS

During May the ANC was refused an application to hold a meetings in Bophuthaiswana.

RESTRICTION OF MEDIA

The Weekly Mail was obliged to return to the self-censorship of the Emergency years in its reporting of revelations about covert structures and operation of the South African Police.

Comment on Statistics

Seventy-nine peoplewere killed during May. This brings the total number of people killed in Natel to four hundred and sixty-one this year. The most adversely affected region was the South Coast which recorded more than double the number of deaths recorded in April. The lower South Coast, which has been relatively quiet during 1992 recorded twenty-four deaths. The figures for the Natal Midiands remain constant with twenty deaths being recorded this month and twenty-four lastmonth. The figures for both the North Coast and Derban declined in comparison to April's figures for those areas..

Hit Squads

Between January 1990 and April 1992, HRC recorded a total of one hundred and nineteen political as:asinations. During this twenty-eight month period, over five times as many such nurders occured as during the State of Emergency years.

Over one hundred of the victims are clearly identifiable as belonging to the anti-apartheid camp- either as officials, members, associates, friends or family members. At least forty-five of these assasinations took place in the Natal Region.

The escalation of political assasinations would seem to be in keeping with the use of the low intensity conflict to destabilise areas to frustrate the ability of crganisations to mollilize politically.

Numan Rights Commission

Ambushes on Commuters

During the month of May there were eleven recorded incidents, resulting in seven deaths and twenty-five injuries, where commuters travelling on buses taxis were ambushed by armed men. Over the last few months there has been frightening ascalation of random attacks of this nature. Particularly concerns have been the frequent attacks that occured on Imball taxts.

Gangsterism

At least five areas in the region have reported the development of gangeter elements over the last five months. The main target of these gangs seems to l been anti-apartheid activists.

During May, two people were killed in Congo settlement in Inanda by a nowl; formed gang suspected of being linked to the notorious Amasinyora gang, of I section Kwaldashu. Community members ailege that a local land owner and South African Police are encouraging the establishment of this gang in an attempt to break the existing rent boycott and undermine community unity.

People's Court

At least four people were killed and two others injured at a people's court in Gamalakhe. The victims were all refugees, were accused of orimes - including rapes - in the community. Members of the People's Court whipped the four to death. The other two injured people were taken to hospital by a monitor in th area. It is the responsibility of political structures in the crea to ensure that t shocking and brutal behaviour ceases imediately.

Focus on imball

In early May, residents of Imbali embarked on a five day stayeway in protest against the role that the security forces play in the conflict in Imbali, Residen demanded the withdrawal of 32 Battalion, the Internal Stability Unit of the South African Police, and the KwaZulu Police. Areas surrounding Imbali join the stayaway and figures indicate that almost eighty percent of the residents participated in the stayaway. The residents of Imball also embarked on mass action, including pickets, marches, public meetings and sit ins at government buildings and consulates. During this mass action over me hundred women v arrested and charged with trespassing and illegal gathering. On the May 8, Pletermaritzburg was declared an Unrest Area. Fifty eeven areas were placed under curfew, and wide powers were given to the security forcos.

Peace Accord

During May, the Goldstone Commission held preliminary hearings in connectison with the violence in Imbali, Umlazi and Esikhawoni. However, reports from the commission seem to indicate that they have decided against establishment of commissions in any of these areas.

In terms of the establishment of structures of the Accord there have been no further developments in the establishment of Local Dispute Resolution Committees in the region.

At a national level the Police Board has been established and has met to discr its operation. Agreements have also been reached nationally to bring private security firms into the accord, and that discussions on the code of conduct for SADF should be referred to CODESA.

SECURITY FORCE FOCUS

Handing Over of Police Stations

Despite the growing body of evidence detailing KwaZulu Police involvement in the violence in Natal there are strong indications that the South African Government is intent on extending the powers of KwaZulu. The government has commenced handing over areas such as Maputuland to the KwaZulu Police and the KwaZulu Police are planning to build new police stations in some areas such as Folwerd. There also seems to be a rejuctance on the part of the government and KwaZulu to bring the SAP and KZP under a single command structure. All this seems to indicate that the South African Covernment has made a concrete decision to extend the life of the KwaZulu Police.

Focus on Imball

During May submissions were made to the Goldstone Commission regarding the role being played by the security forces in Imbili. Concerns raised by the residents include:

That the Security Forces are biased towards Inkatha and that they do not provide protection to residents especially where residents are ANC supporters. On April 30, the police had been notified about the shooting of taxis in Michiankhoul Road. The Police were asked to provide protection. No protection was provided and the next day ataxi was shot at. Since then there were at least three other shootings at taxis in Imbali.

On April 7, members of the SAP escorted a arge group of IPP supporters into Imbali. The IFP supporters then proceeded to throw stones at houses, damage property and fire at residents. Members of the SAP failed to stop or arrest them.

That the Security Forces have been involved in uniawful assaults on residents.

On May 9, the deputy editor of the Natal Witness laid charges of assault against members of the SADF 32 Battalion Mr Kaba Mhkize was assaulted while trying to investigate claims that residents were being harrassed by Security Force members.

Since the declaration of Imbali as an unrest area there have been a number of complaints lodged by residents who claim to have been assaulted while travelling to or from their work.

- That residents are no longer prepared to go to the police because they fear they will be victimized.
- That members of the KZP are operating in imball and have no jurisdiction to do so.

Concern was also expressed over the death in custody of Londi Ntembela and Mbuyi Zondi.

Focus on Inanda

On May 3, David Cebekhulu was assaulted by men wearing balaclavas. The wanted to know the whereabouts of Thunzi Bladla, the ANC chairman in the area. Mr Cebekhulu saw another group of men similarly dressed break open window of Mr Diudla's house and climb into the house through the window.

Mr Cebekhulu also overheard one Afrikaans speaking white person encourage the residents to join the "police" in a plan to kill Mr Dladla.

The police have denied any involvement in these incidents but monitors have expressed growing concern over the role being played by the SAP in the area Allegations made to monitors include:

- That the police are involved in the establishment of a gang in the area wh has already been responsible for the deaths of two people in the communications.
- That officials and members of the ANC have been assaulted on a number occassions by members of the SAP.
- That police have refused to identify themselves to residents during raids (
 homes and that SAP members have been travelling in vehicles without
 registration plates.
- That the SADF have accompanied a notorious warlard Rogers Ngcobo dur raids by Mr Ngcobo on homes in the area. During these raids items have t stolen from homes and furniture and goods damaged.
- That police have turned away residents who go to the Emtshebeni Police station when they have tried to lodge complaints.
- During an identity parade a witness pointed out a member of the CID as being one of the men involved in an assault on Mr Dladle. The CID member then threatened to kill the witness.

Focus on Umlazi

There continue to be reports of KwaZuiu Police involvement in unlawful actic

- On May I, police were involved in the shooting of on youth who while he we waiting for a bus to take him to the May Day rally. After shooting him twi in the back, the member of the KZP then attempted to drive over the body their vehicle and were only prevented from doing so by a group of women the circled the body.
- On May 17, one woman was killed and nine homes burnt by men drassed i KwaZulu Pelice uniform and wearing beloclaves. Residents allege that wh they were attempting to put out burning houses they were fired on by members of the KwaZulu Pelice.

WEEKLY REPRESSION REPORT

FROM

10/06/92 TO 16/06/92

Sixty-three deaths and 77 injuries were recorded in the past week. The death toll increased from last week's figure of 54. However, injuries dropped from last week's figure of 85.

JUNE 16

While there has been some increase in the death toll, few deaths can be attributed to the ANC's Mass Action campaign launched on the 16 June. In fact, despite accusations by Nationalist government members that the ANC's campaign would lead to an increase in violence, monitoring of incidents recorded (especially where the affiliation of victims were known), clearly showed ANC supporters as being the main targets of attacks, rather than the perpetrators. Ten of the 22 deaths recorded on the 16 June, were identified as ANC supporters, 4 as township residents and the affiliation of the remaining 8 were unknown.

Security Forces were responsible for 1 death and 7 injuries, vigilante-related actions for 20 deaths and 12 injuries, and other political actions for 1 death.

· Vigilante Related Actions accounted for 50 deaths and 60 injuries : an increase from last week's figures of 38 deaths and 36 injuries.

Deaths in the PWV were recorded in: Soweto (21), Vaai (15), East Rand (10), Johannesburg (2) and Alexandra (1).

Natal casualties dropped significantly from 10 deaths and 10 injuries last week to 1 death and 3 injuries this week. These figures are the lowest recorded in a seven-day period since the beginning of 1992


Security Force Actions accounted for 3 deaths, 10 injuries and 290 arrests. The majority of the arrests were National Education, Health and Allied Workers Union (NEHAWU) members striking at a number of hospitals.

Hit Squad Actions accounted for 2 deaths, one in Natal, and the other in Transkei. This brings the total number of people killed in hit squad actions to 38.

. The remaining deaths and injuries are categorised as uncertain and other political actions.



Soweto

One death and 3 injuries were recorded on the 10 June in Orlando, when a policeman allegedly went beserk and opened fire on commuters at the Orlando Station. Commuters said that the policeman ran towards the local police station as soon as he stopped shooting. A police spokesperson confirmed the incident but said that the policeman had been threatened and attacked by a group of people. A witness reported that the commuters had pleaded with the police to allow them entry to the police station to indentify the assailant but had been refused.

Pretoria

On the 12 June, in Mamelodi, Alfred Mahlangu (24), a Mamelodi Hostel dweller who is believed to be an ANC supporter, was shot dead by a policeman who allegedly fired nine shots at a group of "comrades" who were patrolling a street in the township. Vaal

On the 16 June, in Sebokeng, police reported that a man was injured and then arrested when police fired birdshot to disperse a crowd of people allegedly throwing stones.

East Rand

On the 15 June, in Boksburg, 234 National Education, Health and Allied Workers Union members were arrested at the Boksburg-Benoni Hospital for allegedly contravening a court order barring strikers from hospital premises unless reporting for duties or negotiating a settlement to the labour dispute.

Alexandra

On the 10 June, 4 people were arrested for the alleged illegal possession of firearms.

W.TVL

On the 15 June, in Rustenburg, 42 National Education, Health and Allied Workers Union members were arrested at the Paul Kruger Memorial Hospital.

W.CAPE

On the 11 June in Hout Bay, 2 PAC supporters were arrested when a row broke out between the two arrested and Cape Provincial Administration (CPA) officials over the demolition of 9 shacks, belonging to PAC members at the Imizamo Yethu squatter camp.

E.CAPE

On the 16 June in Central, Port Elizabeth, police arrested 20 people and allegedly injured one person when they broke up a sit-in at the Department of Education and · Training (DET) offices.

OFS

On the 16 June in Thabong, police reported one death and five injuries when police fired birdshot at people who were allegedly throwing stones. Five people were arrested.

Soweto

The casualty toll in Soweto, still a flashpoint, increased again this week to 21 deaths and 31 injuries (13 deaths and 16 injuries were recorded last week. Incidents were recorded in Dube, Klipspruit, Meadowlands, Moletsane and Orlando East. One train attack which left 12 people injured was recorded in Klipspruit. Six incidents recorded on the 16 June accounted for 14 deaths and 7 injuries. Although the overall tell in this region increased, the number of incidents remained more or less the same as last week. This meaans that there were more victims per attack this week.

Vaal

This sub-region continues to account for the second highest death toll; 15 deaths (higher than last week's figure of 9), with no injuries, were recorded in incidents in Boiphatong, Evaton and Sebokeng. An attack on taxi commuters in Evaton accounted for 6 deaths. Three incidents recorded on 16 June in Sebokeng accounted for 5 deaths.

East Rand

Ten deaths and 24 injuries were recorded, higher than last week's toll of 3 deaths and 4 injuries. Incidents were recorded in Boksburg, Daveyton, Phola Park and Vosloorus. Two train attacks accounted for 7 deaths and 18 injuries. The only incident recorded on the 16 June was an attack on taxi commuters in Vosloorus which left 1 person dead and 1 injured.

Johannesburg

Two injuries resulting from 2 train attacks (one on the 16 June) were recorded.

Alexandra


One death was recorded on the 16 June when the body of a man was found outside the Madala Hostel.

The inkatha institute reported that three people were injured on the 16 June when two taxis were shot at in the U-Section of Umlazi township.

S Coast

HRC

On the 14 June, in Ntinyane, Mr Siprian Maphunulo (an ANC member) was shot dead when a group of "comrades" he was walking with, was ambushed by IFP supporters. At the time of the attack Mr Maphunulo was returning from a memorial service for Sipho Micze, a UDF member killed a number of years ago.


N Coast

On the 14 June in Empangeni, an ANC member was shot dead by unknown people. It was alleged that the victim was threatened by members of the KwaZulu Police shortly before his death and that his name was on a hit list circulating in the area.

TRANSKEI

Umtata

On the 11 June, the Chairperson of the Transkei region of the Transport and General Workers Union, Mr Julayi Hlekiso, was shot at point black range outside his office. Police reported that two spent cartridges from a Makarov pistol were found at the scene.


East Rand

Three National Education and Health Workers Union (NEHAWU) were killed and 1 injured in separate incidents in Katlehong (11 June) and Boksburg (12 June). Two of the deceased were NEHAWU shopstewards. The three, Victoria Mazibuko, Grisell Marubelela and the husband of one of the women were killed when unidentified gumen burst into Victoria Mazibuko's house and opened fire on the occupants. NEHAWU members, employed at hospitals on the Reef, are currently on strike.



NATAL

Three deaths and 2 injuries were recorded in the Durban sub-region. On the 11 June in KwaMashu, 3 members of a gang terrorising the community were killed and 1 injured when they were assaulted and necklaced in a people's court. On the 14 June in Umlazi, a KwaZulu Policeman, on his way to work, was stabbed in the arm.



East Rand

One policeman was shot dead and one injured in separate shooting incidents in Katlehong (10 June) and KwaThema (13 June).

Soweto

Three injuries (two of whom were policemen), resulting from separate incidents were recorded.

Vaal

On the 16 June, police Warrant Officer DSP Coetzee (44) was shot dead when he was forced off the road near the Golden Highway by attackers driving a white Mazda bakkie, registration number PHC 787 T. The attackers were armed with automatic weapons and allegedly stole W/O Coetzee's firearm and identification card.
