MINUTES OF MEETING OF NORDIC OPERATION DAYSWORK 2.APRIL 1992
AT DANCHURCHAID IN COPENHAGEN.

Present were: Malene Campell, Rie Larsson, Marga van der Wahl, Kristina Medin, Thomas Jensen, Uffe Gjerding, Mohammed Tikly (Batlagae Trust) and Tim Maseko (ANC Copenhagen office).

The meeting expressed appreciation, that M. Tikly had taken time to spend a day in Copenhagen on a trip to Europe, in order to meet with the NOD85 Committee.

1. The Qresent situation in Mazimbu and Dakawa

M. Tikly shared the following information with the committee:

- The settlements are to be handed over by the end of June as elaborated in the agreement drawn up with the Government of Tanzania (GOT) and as described in the "National Executive Committee (ANC) statement on Mazimbu/Dakawa". A special word of thanks was expressed to the major involvement of Nordic agencies in the projects until now. In practical terms the settlements will be handed over to the CCM party which originally donated the land to the ANC; but this is only a formality: the settlements are intended for the use of the GOT and the people of Tanzania. The major donors will be invited for the hand-over ceremony in June.

As things stand at present it is likely that Mazimbu will be handed over to the Sokoine University of Morogoro, Department of Agriculture, which already owns the adjacent property. This would mean an extension by 1-1500 student places to the existing mere 4000 in all of Tanzania. Dakawa may become a vocational training and agricultural centre, with a combination of training and production. It is as yet uncertain who will run the institution. Finnida seems interested in contuining its support.

600 students have already been repatriated to South Africa; the rest are expected to return by the end of April. Attempts are made to provide places for students from VTC in similar learning institutions within South Africa. Only 15 ANC people will be left in Tanzania to administer. No more funds will be requested from NOD85 for maintainance of the settlements.

4. Project reporting and visitation

The contracts contain details on narrative and financial reporting on the 3 projects. A delegation of students from Sweden is expected to visit Dakawa as well as the projects in South Africa in June. Formal letters will be written by the Swedish students' organisation to the ANC representatives in Sweden and Tanzania about the Dakawa visit; M. Tikly will coordinate the visits to the 3 projects in South Africa.

5. Words of thanks

M. Tikly expressed warm words of thanks to the Nordic organisations. 1985 had been a crucial year of crisis in South Africa. The Nordic campaign had been a strong moral and financial boost in the struggle. There are now important signs of change in moving towards a new South Africa. The commitment to continuing support to projects within South Africa is extremely important and a logical continuation of the support given in Tanzania. The struggle will take another 5-10 years. It is hoped that the new Situation will be conducive to new relationships between youth in South Africa and in the Nordic countries.

Also Tim Maseko added words of thanks and hopes that the Nordic educational systems could have an effect on future educational systems in South Africa.

AGREEMENT

BETWEEN BATLAGAE TRUST AND
DANCHURCHAID

The following agreement relates to the use of remaining funds collected by the Scandinavian School Student Organisations (hereinafter referred to as "5350") during Nordic Operation Dayswork 1985 (NOD 85). The agreement is drawn up between The Batlagae Trust (Johannesburg, South Africa) and Danchurchaid (Copenhagen, Denmark). Danchurchaid (hereinafter referred to as "DCA") carries the administrative responsibility for the management of the NOD 85 funds as defined in the simultaneously drawn up agreement between DCA and SSSO.

SECTION A

A1. The projects to be supported with the remaining NOD 85 funds are:

- a) The Batlagae Trust Bursary Programme for Returnee Exiles.
- b) Kangwane Work-Study Project.
- c) Khuphuka Skills Training and Employment Project.

Detailed descriptions of the three projects, including budgets, are appended to this agreement.

B1. The \$850 will through DCA contribute the sum of DKK 4.911.187 (exchange rates as of 10/4/92. Approximate equivalent in US dollars: 774.452) for implementing the projects mentioned in A1 above for the period 1992-93. Any further interest will be added to the Batlagae Trust's Scholarship Programme.

B2. The Batlagae Trust shall be economically responsible for the correct use of the funds mentioned under A1.

B3. The Batlagae Trust shall provide DCA with a written progress report every 6 months with the first one at the end of September 1992 and a final report at completion of the project. These reports shall also include a financial report on the use of the contribution, including annual audited reports.

B4. The Batlagae Trust shall further provide DCA with such additional information that may be requested for public information, dissemination or other purposes.

BS. The Batlagae Trust shall facilitate the participation of the official or designated representatives of DCA in any review evaluation or other meetings or missions concerning the implementation of this agreement.

B6. Any remaining balance of DCA/NOD 85's financial contribution and the interest accrued thereto can, with the consent of and in consultation with DCA, be reallocated to other projects or activities of the Batlagae Trust. Or the balance can be returned to DCA.

B7. Any amendments or modifications to this agreement shall be made by mutual consent and in writing.

SECTION C

C1. The Batlagae Trust will carry the administrative responsibility for the Bursary Programme for Returnee Exiles and report to DCA as outlined under B3 above.

C2. Interfund will be subcontractor to administer the DCA grant to the Kangwane Work-study Project and the Khuphuka Skills Training and Employment Project. The Batlagae Trust

will be responsible for the monitoring of the projects, and ensure that Interfund provides reports, with copies to DCA, in September 1992 and at 6 monthly intervals until completion of the projects, where a final report and audited financial statement will be submitted.

This agreement Shall enter into force upon signature by DCA and the Batlagae Trust and remain valid until all the obligations have been fulfilled by both parties hereto.
