



Dear Naidoo,

as already communicated from October 23rd 'to 28th, 1989, UIL will held its 10th National Congress in Venice.

It will take place in a particular political time, characterized by important international events. First of all the speeding up of the European Common Market establishment (with the progressive realization of the Single Act for 1992), to which the European Parliament's recent elections gave a particular impulse.

Together with this international process, the debate on the social dimension of the Common Market has developed. The social aspect seems to be complicated and difficult with problems linked to employment, the Charter on Social Rights, regional and sectorial unbalances and to the environment.

Furthermore, the present changes in Eastern Europe are creating a completely new climate in favour of peace and better relations between West and East Europe.

Finally, it is not possible to postpone any longer a solution to the gap between North and South and to the foreign debt of developing countries.

For all these reasons the UIL 10th Congress will give relevant attention to international issues, also because many qualified foreign delegations will be present.

During the Congress, therefore, debate initiatives will take place on the following issues:

- European Common Market and linked social and trade union problems;
- changes in East Europe;
- international development and foreign debt.

Moreover, considering the growing importance of the Mediterranean and Southern Africa and of the Middle East, the Congress will discuss such subjects.

I therefore invite you again to participate at least to some initiatives of our Congress. Due to a limited hotel receptivity in the Lido of Venice, please let us know as soon as possible the date of arrival and departure of your delegate in order to avoid the need of accommodation in the outskirts of Venice.

The arrival of foreign participants to the Congress is for Sunday October 22nd and departure scheduled for Saturday October 28th.

Later I will send you the detailed programme of the Congress.



OECD Workshop on

Prevention of Accidents involving Hazardous Substances (11-14 Sept.)

(Stockholm 1989)

The ICFTU/ITS Annual Occupational Health and Safety Working Party will take place in Sweden on 6-8 September 1989. This will be followed by a Workshop on the Prevention of Accidents involving Hazardous Substances - focussing particularly on the role of labour, also in Sweden, being hosted jointly by the OECD and the Swedish government on 11-14 September.

The Trade Union Advisory Committee (TUAC) to the OECD will be sending out invitations to trade unions in OECD member countries but the ICFTU has been specifically asked to bring the OECD meeting to the attention of affiliated unions in developing countries.

We would be obliged if you would let us know as soon as possible whether your organisation will be sending a representative to the ICFTU/ITS Working Party and whether he or she would be willing to participate in the OECD meeting which follows.

The ICFTU will pay the return air fare, hotel and per diem costs of one participant from your organisation to the ICFTU/ITS Working Party meeting. If the participant stays on for the OECD meeting, we have been advised that the Swedish government will cover the cost of hotel and per diem for the OECD meeting.

The participation of representatives from developing countries will be of great importance at both meetings. You are requested to let us know, as soon as possible, the name of your representative as the Swedish government needs to have these details well in advance in order to make proper arrangements. Unfortunately, only participants to the ICFTU/ITS Working Party can be reimbursed the air fare and it is not possible for the ICFTU to cover the travel costs of participants wishing only to attend the OECD meeting.

Re: Joint tour of COSATU and NACTU representatives in France

Dear Comrades,

Following the visit in France at the invitation of the CFDT of two representatives of COSATU and NACTU in Nov/Dec. 1988, the Franch Anti-Apartheid Movment (M.A.A.) invites COSATU and NACTU for a joint tour in France on September-October 1989.

This tour will take place in Paris and in 10 / 15 other towns throughout the country, for a duration of approximatively three weeks (proposed period: 25.9. - 15.10. 1989, to be confirmed).

Three aspects will be emphasized:

- 1. The information about the situation of trade-unionism under apartheid to a large public: repression, working conditions, labour relations and labour laws, trade-unions work and workers' mobilisation, etc.
- 2. Information on, and action against French-South African collaboration, for sanctions and the isolation of the apartheid regime. The focus will be placed by the M.A.A. on the involvment in South Africa of the french oil Company TOTAL, and on the national campaign for its withdrawal, as well as other ties, especially when the tour will be going through areas where French companies involved are based.
- 3. Exchange with French trade-unionists at national and local level, on respective experience in each country, especially in sectors in which disputes have been declared, and actions are waged by workers.

  Solidarity action that can be proposed or to be developed with these unions for the following months and years.
- 4. It is proposed to organize public meetings, interviews with the medias, meetings with government representatives, regional and local elected people.

The tour will be organized and coordinated by the M.A.A., which will cover all expenses, including air fares from South Africa. The M.A.A. will ask for co-operation from French organizations involved in its

anti-apartheid campaigns, as well as trade-unions at national and local level, but will keep the entire responsability of the organization of the tour.



Amidst all the turmoil presently in South Africa and the impressive actions of COSATU and the MDM, I would like to ask your attention for the following:

In January 1990 a large-scale womens-conference will take place in Amsterdam, under the name Malibongwe. This conference focuses on the position of women in South African society. This conference is a.o. initiated by some anti-apartheids organisations, convened in "The foundation Malibongwe". The FNV and all its affiliates are closely connected to this foundation and therefore with the set-up of the conference. From all parts of South African society women are invited to participate in this conference. A leading role in The Netherlands is played by Connie Braams, whom you met during your stay in The Netherlands in January 1988.

As for the participation of FNV, it can be noted that we guarantee the participation (i.e. travel expenses and stay in The Netherlands) of 20 women.

In South Africa the counterpart of The foundation Malibongwe is FEDTRAW (c/o Abbey House, 2nd Floor, 57, Commissionar Street, Johannesburg, Feroza Adams).

In our discussion with the organisers of the conference the FNV stressed that the FNV very much wants the trade-union-women from South Africa to be representatives of their organisations, which means that trade unions are to be involved in the selection process concerning the delegation. Via The foundation Malibongwe we put forward our ideas concerning the number of women and from which union they preferably come from. As indicated, the FNV very much adheres to the involvement of COSATU and its unions.



Dear Marty Rosenbluth

I am honoured to have received your invitation to come to the Occupied Territories. I am delighted to accept, and look forward to share with fellow trade unionists and labour lawyers the experiences and developments of the labour situation in South Africa.

I have not yet been in touch with the person that COSATU has agreed to send, but am awaiting word from Jay Naidoo in this regard.





Al-Haq is a Palestinian human rights organisation and the West Bank affiliate of the International Commission of Jurists. As you are probably aware al-Haq has long had a strong working relationship with Professor John Dugard, who presented a paper at our conference in January 1988. As an organisation concerned with basic human rights, we have been paying particular attention to worker and trade union rights, and have established a Labour Rights Project to deal with this issue. In the context of this project, we have worked to establish an exchange of information and experience between trade unions and lawyers here and abroad on issues relating to workers' rights and the right to organise.

We have recently received a small grant from ICCO in Holland to bring a trade unionist and a labor lawyer from South Africa to the West Bank and Gaza. We would like to invite you, along with a unionist from COSATU, to come to the Occupied Territories for a period of about two weeks. I am enclosing a copy of the proposal that we sent to ICCO in order to give you an idea of what the mandate of the mission would be, as well as some information about al-Haq. I am also sending, under separate cover, documentation on the situation of workers and unions here.

We were referred to you by Ms. Lilia Bylos, who mentioned that there was a possibility that you might be leaving CALS to work for the National Mine Workers Union. If this is the case and you need an invitation sent to the union directly, please let us know and we would be happy to send one.

Al-Haq would cover all your transportation and lodging expenses, as well as giving you a per diem to cover your expenses while you are here. We have tentatively planned on the tour being in August, but can postpone it a bit if that is more convenient. We are sending a separate invitation to COSATU. If you agree to come we can put you in touch with the person COSATU will send so you can coordinate with them directly.

I look forward to hearing from you soon, and to meeting you personally. If you have any comments or questions on the mandate for the mission, please feel free to send them to me. If you have access to a facsimile, our number is 00972-2-828-950.

Subject: Convocation of the 10th International Conference

Dear Brothers,

The 10th International Trade Conference of Transport, Port and Fishery Workers is hereby convoked to be held in Sofia, the capital of the People's Republic of Bulgaria, on April 23-28, 1990.

The Conference being a global forum of transport trade unions shall discuss the working and living conditions of transport workers in countries under all different social systems, the problems confronted by the transport trade unions, their activities and struggles for safeguarding workers' interests, the experience of international cooperation in the past and the tasks for developing unity and solidarity for future struggles.

The principal theme for discussion at the conference is to be:

- The impact of technological changes, industrial restructuring and the world economic situation on the transport industry and the consequences for transport workers and their trade unions;
- The trends of privatisation, deregulation, flagging out, rationalisation, take-overs, mergers, inter-modal imbalances and domination of monopolies gaining ground in different branches of transport and the tasks of trade unions for safeguarding the interests of workers;
- The need for economic development, especially for expansion of transport, on the basis of an equitable international economic order, the resources required being made available by further measures of disarmament and assured conditions of peace;

The necessity of the widest possible unity of the transport trade unions and their international organisations, for protecting workers against attacks on their hard won economic and social gains as well as attacks on their trade union rights and ensuring for them proper purchasing power, congenial working conditions, safety, social security and democratic integrated transport policies.

Apart from the Plenary Sessions, there will be section meetings during the conference where representatives of the various branches and regions will discuss specific professional and branch issues, and suitable recommendations and tasks will be drawn up.

As a long standing practice and tradition, our conference is open to representatives of all trade unions of transport, port and fishery workers, regardless of national and international affiliation and orientation. All participants, delegates, observers and guests can take part in the discussions with equal rights, both in the Plenary Sessions and in the branch and regional meetings.

We believe that the participation of your representative(s) in our conference will help to bring about a wider exchange of opinions on problems common to all transport workers and contribute to the strengthening of unity, fraternal co-operation and solidarity among all trade unions of transport, port and fishery workers in the struggle for better working and living conditions, for defending and extending trade union and democratic rights, for democracy, national independence, social progress and peace.

We shall be obliged if you could kindly let us know at your earliest convenience, but not later than 30th November, 1989, whether it will be possible for your union to accept our invitation to participate in the 10th International Trade Conference of Transport, Port and Fishery Workers. In case of an affirmative reply, please name the participant(s).

Upon reciept of your reply we shall forward to you further details regarding the conference and the draft documents before the 31st of January, 1990.
