re: Implementation of Finnida's assistance to the VTC

In order to facilitate their support, Finnida is proposing that the Educational Foundation of the Finnish Social DemocraticParty (finnish acronym TSL) be the implementing agency for the VTC component of their humanitarian assistance to the ANC. It is envisaged that the arrangement be along the same lines as that with the Finnish Library Association.

I mentioned this to Cde Tikly over the phone who, I believe, in turn raised the matter with you in Lusaka. My understanding is that in principle we have no objection to TSL's proposed role and I informed Finnida accordingly. TSL is a progressive NGO and has worked similarly with SWAPO's Vocational Training Program in Angola. I have no reservations in recommending them as an implementing agency.

To concretise matters, it is proposed that a joint ANC-TSL-Finnida consultation take place late August at Dakawa to formulate a plan on how to implement Finnida's assistance for 1990(as already agreed during the February negotiations) as well as for the future. This consultation will also provide Finnida with the data necessary to allocate the required funding for the VTC.

Kindly advise as soon as possible(telex would be desirable to speed matters) your views on these issues.




