Thank you for agreeing to offer your financial support in the amount of R25,627.80 in this respect. I hereby wish to acknowledge receipt of these funds on 8 November 1994. A copy of the relevant bank voucher is attached.

Your assistance is particularly appreciated, as we approached you on humanitarian grounds after the Russian authorities and the United Nations High Commission for Refugees were unable to help this student. He has arrived in Durban and has been re-united with his parents and family.

An amount of R2 354.10 (US\$ 665.00) was paid towards his ticket, as reflected in the attached

copy of a letter from the South African Embassy in Moscow.

The remainder of the funds will be kept to cover special needs of returnees which occur from

time to time, and we will provide KZA with a report on this during 1995.

Once again, we express our sincere thanks for your assistance in repatriating this young South

African. We very much appreciate your financial support in this way, and your moral commitment to our country's young exiles who are enthusiastically returning home to face the

challenges of a long-awaited democratic future.
