


#### Provision of information on foreign EVD markets - trade promotion







The EVD (Netherlands Foreign Trade Agency) is part of the Ministry of Economic Affairs and is the government's national advisory service for the export industry in the Netherlands and for companies preparing for internationalisation. #### Opportunities for public procurement

  - Projects: preliminary information about concrete proposals by a country to carry out a programme of work, or to provide goods and services
  - Tenders: invitations to submit tenders to carry out work, or to provide goods and services






