- c) that the Immigration and Labour selected Boards be constituted with men and women from varying work spheres and are fully equipped to decipher worthy and unworthy expatriate employees;
- d) that Batswana understudying expatriates should be identified, informed and their progress on the job evaluated by persons other than expatriates being understudied .

That in order to curb misappropriation of FAP funds administrative boards be formed at regional level to monitor on a regular basis the management and utilisation of such funds.

That members of the Central Committee of the Party promptly visit those constituencies which do not perform well at every election to review the Party membership and enthusiasm among people.

That there be introduced an Act of Parliament in Botswana to deal with $\hat{a}\200\234$ $\hat{a}\200$

indiscriminate littering by making it illegal to litter and punishing offenders accordingly.

We note with concern the unacceptable behaviour and attitudes of government officials in general towards members of the public.

Specially, we y: note that, as stated by the 1982 Presidential Commission of Economic Opportunity, there is widespread resentment of Government officialdom, based on the feeling that officials are " a law unto themselves" and that complaints about inefficiencyy delay and malpractices are useless since officials are judge and jury in their own case. We believe this is an extremely serious problemy and that there is indeed a widespread tendency among officials in all branches of government to Iorget that they are servants of the public. To this end South East Region moves that the election pledge as cantained in Chapter 12 Paragraph 8 of the 1974 Election Manifesto be implemented without agdelay.
