# Commision for External Organisation - Report.

# 1.0 Introductory Remarks.

Since its institution, the CEO has met only once (09/08/88). The meeting was basically of a ground-braking nature, aimed at introducing the members to the tasks of the Commission as well as mapping out its terms of reference. In this regard, it was agreed that practice, as well as a gradual start will best introduce the CEO to its work.

# Observations of the Meeting.

- 2.0 Meeting agreed that the priority area of the CEO shall be the Lusaka region, and the first step in this direction shall be to meet with the RPC.
- 2.1 Meeting agreed that in order for the CEO to carry out its task effectively, it shall need to be exposed to the reports submitted to the Presidential Committee by different departments and formations of the movement. This, it was observed, shall equip the CEO with an up-to-date state of organisation of these departments and formations.

  2.3 The CEO further noted the need to draw the attention of the general membership of the ANC to the NCC 2 decisions and resolutions on; a) membership of the ANC. In this regard, a draft proposal of a standard "Application Form" has been prepared for consideration.
- b) cadre policy.

#### 3.0 CEO Staff.

The meeting noted the need for the CEO to have a fully functioning administrative staff, as well as facilities. The CEO wishes, in this regard, to draw the attention of the NEC to consider this matter. The names of comrades Conny Ndlingea and Nomsa Msimang are hereby submitted as candidates for the said administrative staff.

### 4.0 Membership "Internal"Bulletin.

The CEO made an observation on the need for contnous flow of information within the ANC on developments within the ANC, inside the country and internationally. Such an objective, it was agreed, can best be served by a "Membership Bulletin". The details of this projects shall be made available in due course.

#### 5.0 General.

The meeting noted the need for the SGO to send out circular-letters of introduction to different departments and formations of the ANC on the existence of this commission as well as its terms of referrence. This, it was agreed, shall facilitate direct contact between the CEO and different departments and formations of the movement.

# 6.0 Meeting between the CEO and the RPC.

The CEO held a meeting with the Lusaka RPC on 24/08/88. The meeting was basically of a familiarisation nature as to the state of organisation of the Lusaka region, as well as the workings of the RPC. A further meeting is planned to take place soon and shall be engaged in a detailed examination of this region.
