The establishment of effective programme to implement the provisions of the National Peace Accord.
The representation and attendance at RDRC and LDRC meetings.
The establishment of the nominated LDRC's.
The issue of acknowledgement of the KwaZulu Government and its structures by the ANC (Cosatu) Alliance.
The access of venues in KwaZulu to all parties and the practise of free political activities in all areas.
The repatriation of "refugees". A programme needs to be agreed how these refugees could be Identified and repairs affected to damaged property.
The role and powers of the Amakosi must be agreed.
Procedures Must be established and agreed for possible withdrawal from the NK RDRC and LDRC's. Any withdrawal from the structures disrupts the smooth operation of the structures for months even after the return of the party suspending participation.
Protection for participants of RDRC's and LDRC's.
Any other Items which the participants might wish to relse.
As the position in Natal is very tense at the moment it is imperative that the proposed meeting should take place as soon as possible. The successful outcome of this meeting would lead to the saving of lives.
