Agreement on student accommodation

Dear Mr Blair,


Your letter to the Secretary for Finance, Economic Planning and Development of 30 April 1984, which was forwarded to the SIDA Office in Harare, refers.

SIDA notes with interest the audited financial statement on the utilization of the SIDA grant and finds it entirely satisfactory in terms of Article V of the Agreement.

SIDA notes with satisfaction that 16 students from SADCC countries have been given university residence, although these do not include any students from Angola, Mocambique or Tanzania. Furthermore, two students from South Africa and one from Namibia have been given residence. These also belong to the group to be considered under the Agreement, to the extent that they are refugees, which we understand is the case with the two South African students.

Thus, 18 students that qualify under the Agreement have been given residence by the University, out of the approximately 100 places that the SIDA grant financed. It is our hope that next year will see an increased number of students from SADCC countries as well as refugees from South Africa and Namibia being given residence by the University.

AGREEMENT WITH SIDA ON STUDENT ACCOMMODATION

In terms of article 5 of the agreement between the University and SIDA as recommended by the Ministry of Education and approved by your Ministry, I write to provide the information on the utilisation of the SIDA grant for the expansion of student accommodation and on the number of students from SADCC countries admitted to University residences.

Attached is an audited statement of the expenditure of the SIDA grant to the University.

Also attached is a list indicating the foreign students who are currently accommodated in University residences indicating their names, the residence in which they are accommodated, their programme and their nationality.

I trust that this information satisfies the University's obligations in terms of article 5 of the agreement. I presume that you will forward a copy of this information to the Swedish Embassy. Representatives of your Ministry, of the Ministry of Education and of the Swedish Embassy are, of course, welcome to visit the Mount Royal residence whenever is convenient.

Dear friends,

At the meeting of African Ministers of Education in Harare June/July 1982, discussions were held on the possibility of increasing the number of students from SADCC countries admitted to the University of Zimbabwe. The University stated that the shortage of accommodation hampered intake of students. The SIDA representative at the meeting promised to look into the chances of getting funds to obtain a hotel or the like in Harare to ease the accommodation problem.

At the same time the University started to look for properties and to process the proposal through the Ministry of Education and Culture to the SADCC machinery.

Discussions were held with EEC, WUS and UNHCR on the funding and implementation of the project.

Through Swaziland the project was presented in SADCC and formally endorsed as a SADCC project to be presented to Sweden for funding.

SIDA took a quick decision to supply SEK 2,4 million towards the project and an agreement was signed with the University in July, 1983. The Ministry of Education and Culture and the Ministry of Finance, Economic Planning and Development also signed for Zimbabwe Government.

The actual handing over of a check for the SEK 2,4 million will take place on 19 October, 1983, in Harare.

The Agreement made it possible for the University to purchase the Mount Royal Hotel on Rhodes Avenue/8th Street in Harare. There will be room for about 100 students. The University wants to mix the student population in the house for social and other reasons, so there will not only be students from SADCC countries and refugees students from South Africa and Namibia.

The gift has rather increased the total capacity of the University to house students.

In response to this offer the University has vowed to increase its intake of qualified students from SADCC countries and refugees from South Africa and Namibia. It is envisaged that at least a quarter of the 100 should be used for these non-zimbabwean-students.


If that target shall be met the number of qualified applicants from outside Zimbabwe will have to increase. It is not a matter of quota or automatic admission to courses. However, the SIDA contribution will make the University more willing to take in students from outside.

The Student Union on campus has made it very clear that non-zimbabweans can not take places from zimbabweans at the University. Intake of outsiders could only be allowed if there were spare places, which do exist in certain subjects.

You are advised to inform relevant ministries and organizations of the expanded possibilities to send students to the University of Zimbabwe, quoting the agreement between SIDA and the University. For a prospectus of courses etc they should write to

A G R E E M E N T

Between the Swedish International Development Authority (hereinafter referred to as SIDA) and the University of Zimbabwe (hereinafter referred to as the University).

Article I

Swedish Contribution

In order to expand the student accommodation facilities at the University and, thereby, the access of students from Southern Africa Co-Ordination Conference (SADCC) countries as well as refugees from primarily Namibia and South Africa, who are qualified for admission to University of Zimbabwe courses, to residential accommodation, SIDA shall, subject to the provisions set forth in this Agreement, make available to the University, on a grant basis, financial resources up to an amount not exceeding TWO MILLION AND FOUR HUNDRED THOUSAND SWEDISH KRONOR (SEK 2 400 000). The contribution shall be financed out of the Swedish funds available for regional co-operation within SADCC.

Article II

Disbursement

The amount of SEK 2 400 000 shall be made available for disbursement for purposes according to Article III of this Agreement. Payment shall be made to the University. Disbursement is subject to presentation of a suitable housing alternative and of SIDA approval of the alternative presented.

The disbursement shall be reimbursed to the University after the University having presented invoices of the acquisition.

Article III

Utilization of the Swedish Contribution

The resources made available by SIDA shall be utilized for expanding student accommodation at the University. The objective of this expansion is to alleviate the acute shortage of student residential accommodation at the University and thus enable a larger number of students from other member states of SADCC and refugee students from primarily Namibia and South Africa, who are admitted by the University to its programmes, to be accommodated by the

University. At least one quarter of the increased residential capacity, made available through the SIDA grant, shall be available with priority for such students.

Article IV

Administration

The University shall have sole responsibility for all administration and practical work in connection with the acquisition, furnishing, repairing and maintenance of the housing facilities financed by this project.

Article V

Information

The University undertakes to submit to SIDA through the Ministry of Education and Culture and the Ministry of Finance, Economic Planning and Development a financial report and audited accounts on the utilization of resources made available under this Agreement upon completion of the project, but not later than 1st July, 1984. The report should also contain information as to the intake of students from SADCC countries as well as refugee students.

The University shall also afford SIDA in conjunction with the Ministry of Education and Culture and the Ministry of Finance, Economic Planning and Development opportunity to inspect the buildings and the records.


Article VI

Entry into force and termination


This Agreement shall enter into force upon the date of signature and shall remain valid until both Parties have fulfilled their obligations arising from it or until six months after written notice of cancellation is given by either of the Parties.
