Dear Chief,

Thank you for your last letter. I am sorry however to have taken

so long to reply. There are two main reasons for this. 1) It has not been easy to compile an easy list on Mxolisi. There have been too many people who have had one thing or another about him and his general behavior. On the money side, most have been suspicious but with nothing concrete. 2) As a

student, I have been trying to chase the syllabusl'while at the same time trying to get Cap and Mandla's admission this side. There are few of us at the moment trying all.

•

Here are some of the easy to point things about Mxolisi. Others may come from Ben and others may be dublicated.

- a) He addressed a meeting just after I wrote you a letter. The meeting was at Wisconsin. I am reliably told he was paid for this even though I do not know how much. In this meeting as usual he had taken liquior. He attacked ANCSs Leaders for wishing to kick him out. But said they dare not do this because he has raised thousands of \$3 for the movement. He made a number of contradictory statements, and when he was challenged by a Fellow from Kenya after the meeting, he punched this man.
- b) He has refused to COOperate with us by handing over to us or to The Foundation The files of his Lutuli Foundation. To me he said straight he would not cooperate because we reported him to you without asking him. I told.him that we have no power to force him to COOperate with us, but he should know that we are the servants of the Organization where private perSOnal friendship comes last. He then said he will COOperate with me but not with Ben. He has not done so. The Foundation's Head Office has asked him to pass on the files, but he has not done so. My fear is that he has distroyed them, because they are incriminating. I am told he has bought a farm.
- 0) He has started a Jordan Foundation. To me he denied that he was the founder but he admitted that he was one of the Trustees. When I asked him why he accepted a position in a body that will be a rival to his own, he could not come clean. But to another question about his failure to consult with his ANC Comrades on the matter, he said he said he was under no obligation to do so. There is no doubt in my mind that he started it so he could speak in the name of South Africans in order to get money for his private use.
- d) When we asked histabout the Foundation (Lutuli) he had started and its financial position, he said the Foundation does not owe anybody, it has no idebts. When we asked him about the money he has been receing as Houneraruim he said he was using this money to pay the debts he inoured while running the Foundation.'If you Can find sense here Chief, you are welcome'.
- e) In every meeting, including academic meetings, he has been boxing peOple to donate money for the suffering Africans of South Africa. This cheapens us and makes us peOple who look for sympathy instead of bemng serious. Ben pointed this out to him, but it made no impression because he has done it again just recently, I was told this by a Black American who is our strong suporter but who does not approve of this for the same reason for which Ben objected.

f) Some of the complains have been on childish exagerations which makes his $a\geq 00\geq 30$ listeners to wonder whether it is not South African to tell lies. People in general do not want to feel they are being decieved.

I now wish to turn to the other point you wished me to elaborate on. Chief, as you know, America is not favourably disposed towards ANC. The FBI even for the local Blacks, $3ta^200^231$ uses other Blacks as Agents, invariably they are of goodâ 200^230

education and well trained for their job. Theygreatest thing here to day is African Identity and Pan Africanism. There is more emotional rhetoric than ever. An inexperienced representative, or an impressionable person can be a

liability to the Movement than an asset. What I mean, is that we need here a person who is cool rather than an enthusiastic, unemotional than emotional, who must know that people are not Angels. On the Exiled African front, we need a true ANC maturity. There are Boys who use to be PAC because they were under spells of illusions or deceit. To them ANC is all that which in fact it never was, but there is no point in dismising them off hand as cranks because they are not all cranks but as Nelson once said at Robben Island, some are lost children of ANC. I am not here advocating the waste of time by trying to go fishing and arguing with the disillusioned PACs. But I mean, at Robben Island we met people you may not remember but who would say, if ever there was a man who made me see light was Oliver Tambo. You may not even remember what you did to them, but they do not forget'gou and what you did. You treated them like people, even though they had bet aying all sort of things about you personally and about your Organization, things they believed to be true when they were no truth. What we need is a complete distruction of PAC every where and the best agents are the former PAC who can say, look I was a member of that rubbish. There are people in ANC

who will not be, it does $\hat{a}\200\234$ matter how well intentioned they may be. corrupting society. I have been a Year now here, and I can say I do understand a little of it. It is a Society of climbers and conspicious consumption, it is easy to fall prey to it. Mxolisi is a typical example of this.

is purely Social Psychology. But having looked into the curriculams of most of the Universities here on the field of Social Psychology, I have not found one that even indirectly deals with our problem. So to meet our problem, I have tried to combine two things, neuroâ\200\224psychology and Cognitive Psychology. In my Cognitive side the emphasis is on Memory Thinking and Attention. I felt I need the Neurological side to understand the Biological end of how biologically we as peOple encode the information we receive through our sense organs. So for my minor courses I do have Social Psychology with three courses already in it and will have neuro~psychology as another. I needed only one, but for our purpose I need two. So infact I have not left out our basic problem, but I hav have changed the approach to it. My main misgiving about Social Psychology erformed and

per se is that it deals with fate acc0pmpli, behavior already

itâ\200\230a hit or miss affair. I am not saying the approach I have chosen is lâ®O% but if we know how information is encoded, it will be easier for us to devise ways of decoding them or obliterating it by encoding new ones which will be come primary and there by supress the other.

I will now come to the good papers by Our Office in Lusaka and the one by MB, on the Bantustans and the so called leaders at home. I will not like to repeat most of the things which have been cmrrectly pointed out by the two documents. But I would like to point this out. I think we must not only see the Bantustans as a fact but we must also act in recognition of this. More than this, we should recognise that there are two main divisions among the so called leaders and that in the two divisions there are also two subdivisions. Firstly, there are Oportunists who have accepted Bantustans for personal gains while on the other side there are peOple who have accepted because they felt it is better for the honest peOple to take it than have the Oportunists. This is the first division. In both divisions there are the bright fellows and the unbright. To characterise the groups, there are the Kaisers and the Mangosuthu Each of the two have their subâ\200\224groupings as I have pointed above. Matanzima is a fox and will uSe any Opportunity for self. Buthelezi is our men and will do what he thinks is for ANC. To lump them together is incorrect and unwise in my Opinion. We can trust Buthelezi but we cannot trust Matanzima. In isolation Buthelezi can make mistakes like any of us, but on most things he remains on the ball. People at home may be Oppressed but they are not fools nor can they be taken in. They have on the main rejected Bantustans as ANC have taught them to, but they have been realistic being on the melting pot. They have seen a man who talks their language, the language they have been taught by ANC and
