I joined them in the car and we proceeded to a corner where we met a man whOm I subsequent thereto, came to know as Khalipi. He, Khaliphi, was on foot and he joined us in the white cressida. S.

We them.proceeded to captain Viljoen's office in Potchefstroom. There Shakes Tshwaedi, Brandt Balete and Khalipi alighted and the driver of the cressida and myself remained in the vehicle. Later Shakes Tshwaedi returned and called us into Captain viljoen's office. Only Khalipi was ordered by Shakes TShWani to remain behind and wait for an attorney.

In Captain Viljoon's office, we found Captain Viljoen himself and a PoliCEman known as J.J. Steyn. Later a man arrived and was introduced as an attorney. There Captain ViJjoen said I should be his informat and if T dn en. T would never be attached and the case that was then pending against me, would be withdrawn. 7.

On Friday during the same week, I was picked up by the Police who had already arrested other people. Members of the police I can recall wore J-J. Stcyn and a black poliuc man known as "Burrsh". I was detained in Pntrhefstroom and was released on Sunday. One policeman who is stationed in Uraniaville Klerksdorp told me that I was being released because I was their lnrnrmanf :nd/Zhnnld nnvar e," Lka& tn

WILLIAM "DOCTOR" MBIPHA was arrested on 24 May 1992 and that was before I left for Randfontein. on Monday 1 June 1992 at about 7hours. Brandt Dalete and Shakes Tshwaedi arrived aL my place of residence at Luipardsvlei 30. Shakes Tshwaedi said to me that Capbaln Vlljuen wanted to see me as soon as pOSSIDLe. They pxumlsed to transport me back home.

We then drove to captain Viljoen's office in Potchefstroom but did not find him in his office. Later Captain Viljoen arrived. Brandt Balete remained in the vehicle and Shakes Tshwaedi and I went into Captain Viljoen's office. Shakes Tshwaedi said to Captain Viljoen, "hier is die man,ons het die man gekty". Captain Viljoen asked Shakes Tshwaedi as to whether they had said everything to and whether I had agreed whereupon, Shakes Tshwaedi replied In the affirmative. Captain Viljoen said he had already telephoned April Tshwaedi and they should take me to him.

I was taken to April Tshwaedi at Shakes Tshwaedi's house in JOUbertOn Klerksdorp. April Tshwaedi said if I could help them in William "Doctor" Mbipha (whose case is still pending in Ventersdorp and is on the roll on 19 June 1992), Captain Viljoen will cause my own CHRP which was nn thP r011 an 18 June 1992 in Klerksdorp Regional Court to be withdrawn. While we were still there, two white policeman namely:-J.J. STEYN and the other one whose name is to me unknown, arrived. April Tshwaedi acted as an interpreter but said things that I did not say but things that they wanted me to say. He said I had told him that when Brandt Balete's house was set alight, I had seen William "Doctor" Mbipha switching a light off so that arsonists could not be seen. He further said the AK47 with which William "Doctor" Mbipha is charged with in Ventersdorp Magistrate's Court is his (Mbipha's). He said I say I had :tayed at Mbipha's house and had on a number of occasions seen him hid the AK47 outside his house. At that time the companion of J.J. Stein was writing down what April Tshwaedi said. He later said he was-tired and J.J. Stein, Who I am told is the investigating officer in Mbipha's case continued writing down what April Tshwaedi said. The AK47 was described to me and a sketrh thereof was also made. I was told to testify in Court against William "Doctor" Mbipha abOut the AK47 although I did not know anything about same.

On Thursday 4 June 1992, I was fetched from my home to Potchefstroom where we did not find Captain Viljoen. I put up at the Police Barracks in Potchefstroom together with a policeman known as Buffel. On 5 June 1992. I was taken to Captain Viljoen's office where he (V11jnpn) gave me an amount of R2000,00. I aigued Lu acknowledge receipt thereof. Captain Viljoen said when I return from Regional Court Klerksdorp, on 18 June 1992, I i4ould go to his office to collec

On 18 June 1992, my case in the Regional Court, Kierksdorp was withdrawn as I was promised. I wish to state explicitly that I was told that among the things I was to do, was to shoot the following WILLIAM "DOCTOR" MBIPHA; KORTHAN HAIKANA; JAN MAIKANA: and FRANS HAIKRNA and that I should have done that on 5 June 1992. I was told the police vehicle would be around to take me away after the shootings.

I further wish to put on record the fact that the people whom I have been told to shoot. are taxi OWnera in KLERKSDORP. I further wish to put on record that April Tshwaedi is a suspended policeman (member of the Riot Squad) and is the younger brother to Shakes Tshwaedi like Brandt Balete, is a taxi owner.
