- John Pampallis briefed the meeting of his work since his arrival. He received close collaboration from Sinnika and Ike.
- 2. The following Departments/Sections have been approached (or will be) for either documentary material and museum items:-

4. After John Pampallis leaves, a Sub-Committee comprising Sinnika, Ike and Zwelakhe will coordinate the Project. There will be a separation between (a) archival material and (b) meseum items.

Zwelakhe will write to the Director's office requesting transport for the team.

- 5. All material will be collected by the end of January and packing and shipping done during February. An inventory list of all items will be sent to Johannesburg (Building and Technical Services Department, cc. M.Tikly) for purposes of customs clearance.
- 6. The amount of material will be about twice the amount estimated in the Project Proposal. Finnida will be asked for additional funds.
- 7. TCRS is deemed the suitable shipping agent. Zwelakhe and M.Tikly will call on 23 December to discuss details and CTCRS obtain a proforma invoice for submission to Helsinki (K. Oleng). TCRS will be paid in Geneva.

- 8. Ike Maamoe agreed to remain at Mazimbu until the end of February 1992 to assist with the collection and despatch of material. Consideration will be given to remunerate him \$1000, the allocation in the Archives Project Proposal earmarked for a month's salary for an archivist at Fort Hare University. M. Tikly will confirm this after consultation with K. Oleng in Helsinki.
- 9. Ike Maamoe's CV will be sent to M. Tikly for despatch to the University of Fort Hare.
- 10. The overall cost of the Project will be about US\$11,000 (not US\$6,780). The ANC and FINNIDA will be requested to make the additional amount available.
