## MEMORANDUM OF AGREEMENT BETWEEN NATIONAL MILLING CO. AND AFRICAN NATIONAL CONGRESS (ANC) OF SOUTH AFRICA.

- 1). By mutual agreement A.N.C. (S.A). has surrendered 11.064 bags of rice of 50kgs. each to the National Milling Company and the latter acknowledges receipt thereof.
- 2). The National Milling Co. undertakes to supply ANC (S.A.) with rice of the same quality as ANC(S.A) has surrendered to the National Milling Company or equivalent thereof periodically as the A.N.C. may call.
- 3). As per request of the A.N.C. (South Africa) The National Milling has agreed to rate or grade the quality of the rice it has redeived from the A.N.C.(S.A.) in order to fulfil clause two (above) of this agreement.
- 4). For rice on call the A.N.C. (South Africa) undertakes to give the National Milling Company up to thirty 30) days notice.
- 5). On the question of distribution, sale or profit made on the surrendered rice the A.N.C. undertakes to have no hand or interest in it making this aspect the sole responsibility of the National Milling Company. The National Milling Company, in turn, has agreed to waive all expenses relating to transport or storage of the surrendered rice.
- 6). The A.N.C. (S.A.) and the National Milling Company have agreed that the latter will keep a correct record of rice stocks held or owed to the A.N.C. (S.A.) and to submit such statements from time to time or as will be requested by the A.N.C.
- 7). The National Milling Company and A.N.C. have agreed that the Government of the United Republic of Tanzania shall be the guarantor of this agreement through the Office of the Prime Minister of the United Republic of Tanzania which is responsible for the welfare of the A.N.C.(S.A). as a liberation movement.
