Dear Sankie,

with reference to the discussion we had together with your predecessor Tony Seedat about a possible expansion and intensification of our direct co-operation I have the pleasure to inform you that we have been able to secure additional funds for a financial contribution to the following project proposals:

1. In order to intensify and accelerate the communication between Lusaka and representatives of groups from inside South Africa we have allocated the amount of Deutsche Mark 50.000,- to meet costs of travel and accommodation.

A practical procedure for the utilisation of this fund has to be arranged, as we do require precise documentations of all expenditures (invoices) for our accounting purposes.

Funds necessary to meet the costs of accommodation in Lusaka could be channelled through the office of Dr. Könitzer, our representative for Zambia.

Tickets for flights between South Africa and Lusaka could be provided either by a South African based travel agency nominated from your side, which will invoice us directly or booked through our travel office through SAA representations. In this case we would require timely and precise information about the persons supposed to travel for our booking.

These exchange programmes can be organised on an ad hoc basis without prior consultation, but we would appreciate if we could receive a short final report on the activities undertaken within the programme.

2. In support of ANC research programmes we have allocated the amount of Deutsche Mark 30.000,- for research activities as described by Tony Seedat.

We would suggest that this fund should be used for particular research activities of limited duration and clearly defined objectives, as we are unable to commit ourselves to long-term salary payments or scholarships, but have to use the instrument of short-term expert contracts in support of such activities.

The following has been agreed between the **Friedrich-Ebert-Stiftung**, represented by Dr. Ernst J. Kerbusch, Director of the Department for International Cooperation and the **African National Congress (ANC)**, represented by Ms. Sankie Dollo Nkondo, Chief Representative for the Federal Republic of Germany.

1. Whereas the Friedrich-Ebert-Stiftung in compliance with its aims and objectives shall contribute to the information and dialogue activities of the ANC-Representation in the Federal Republic of Germany by
 - a) providing financial assistance of the amount of DM (Deutsche Mark) monthly,
 - b) disseminating information material on South Africa through the Foundations network and
 - c) utilizing information on the situation in Southern Africa within the educational programmes.
2. Whereas the African National Congress shall
 - a) make available all publications and information materials issued by the organization for such purposes,
 - b) provide information and analysis about new developments in South Africa and the Southern African Region,
 - c) give regular personal briefings on important aspects of the political, social and economic developments in Southern Africa and within the respective international relations.

We hope that the unbanning of the ANC will provide the necessary conditions for increased political activities inside your country and for an intensification of our bilateral co-operation.
