THE UNITED STATES AFRICAN-AMERICAN CITIZENS, DO HEREBY PETITION, THE REPUBLIC OF SOUTH AFRICA, STATE PRESIDENT MANDELA, TO ASK THE REPUBLIC OF SOUTH AFRICA PARLIAMENT, TO IMMEDIATELY ENACT A LAW: (1) THAT WOULD GRANT FULL SOUTH AFRICAN CITIZENSHIP, TO UNITED STATES AFRICAN-AMERICAN CITIZENS. (2) THAT UNITED STATES AFRICAN-AMERICAN CITIZENS, WOULD HAVE DUAL CITIZENSHIP, WOULD HAVE BOTH SOUTH AFRICAN AND UNITED STATES CITIZENSHIP.
