At this time of great peril to humanity, we should like to invite you to join us as HONORARY SPONSORS of the World Constituent Assembly, to convene near the end of 1990, and also to serve as continuing Honorary Sponsors of the Provisional World Parliament, which will hold periodic sessions until a Constitution for Federal World Government is ratified and implemented.

In doing so, many of the Ambassadors of the United Nations may continue to serve as members of a World Legislative Parliament, and other high minded personnel of the U.N. and its agencies will continue to serve under a Constitution for Democratic Federal World Government -- which is better designed and given sufficient authority and funding to achieve peaceful solutions for ALL global problems.

Honorary Sponsors are not committed to support every detail that may be decided, but are committed to support this general process for reaching the objective of peaceful solutions to global problems, in the context of democratic world federation, so that humanity may survive on this planet.

CALL TO A WORLD CONSTITUENT ASSEMBLY

To convene in December of 1990

THE PREDICAMENT OF HUMANITY:

At the time of issuing this Call in 1989, Humanity is confronted with many extreme global problems, some affecting the survival of most people on the planet. These problems include:

- *Climatic changes already underway, because of excess carbon dioxide and other pollutants in the atmosphere, threaten universal disaster soon, including the possible starvation to death of hundreds of millions or even billions of people.

- *No one is safe while nuclear weapons remain aimed and ready to fire at a moments notice, and while other weapons of mass destruction continue to be developed and deployed. As more nations gain nuclear capability, human survival is threatened by wars starting anywhere, either accidental or deliberate, made even more deadly by nuclear fallout and nuclear winter.

- *The economies of most countries are crippled by debts, lack of funding, unemployment and inflation. Adequate development and environmental repair cannot go forward until a new global financial system is instituted, designed to serve peaceful human needs.

- *Safe and sustainable energy supplies must be developed very rapidly to replace the use of polluting fossil fuels, deforestation for fuel, and nuclear fission reactors which each year produce hundreds or thousands of years of radioactive dangers to all life on the planet.

- *Food production per capita of world populations is declining for many reasons, while population is increasing.

- *Earth's oxygen supply is endangered by pollution of the oceans, the death of plankton, and destruction of the rain forests, which together recycle most of the oxygen people depend on for life.

- *With increasing production by chemical processes, in both industry and agriculture, toxic wastes are rapidly accumulating, with few (if any) safe places for disposal.

- *The capabilities for production with highly advanced technology in a few countries, are increasing the gap between the "haves" and the "have nots", and reducing the employment and livelihood opportunities for most people in many countries to primitive levels.

- *The spread of ozone holes in the atmosphere, rapid loss of topsoil and fertility, floods and hurricanes arising from conditions which transcend national boundaries, acid rainfall and snowfall, and expanding deserts, are some of the dozens of environmental problems which have become global problems of common concern to people everywhere.

- *Many millions of people are likely to seek refuge from unliveable environments soon, including large percentages of the people of some countries.

- *Human welfare, environmental health, and basic human rights are sacrificed everywhere so long as nations allocate large amounts of money, resources and scientific talents for armaments, and give priorities for military purposes. This now costs the people of Earth a trillion dollars (US) per year, with no safety for anyone. The same amount needs to be spent instead on rescuing Earth from climatic and environmental catastrophes, and the production of goods and services for useful peaceful purposes.

The global crises and problems mentioned herein, as well as many others, have been accumulating for many years. Solutions are now required quickly, and simultaneously in many cases, in order to avert or minimize global catastrophes. Experience during the past 40 years, and longer, demonstrates that adequate solutions are not possible to negotiate among sovereign nations--neither outside nor inside of the United Nations Organization.

WORLD GOVERNMENT IS REQUIRED:

To devise and implement adequate solutions to these problems and others which transcend national boundaries, as well as for global problems which will continue to arise in the future, requires a World Government immediately, particularly within the time frame allowed by the extreme nature of some of the problems. By World Government we mean a federal world government that is democratic in its own structure and designed for civilian administration. World Government is, in fact, the first practical requirement for survival and progress, not a dream for the future after human civilization has been destroyed by unsolved problems.

The federal World Government must include an elected and fairly representative World Parliament, given authority to enact world legislation directly to solve world problems and provide for the management of global and trans-national affairs; a World Executive and Administration given authority to implement the world legislation directly, while respecting the jurisdiction of national governments over their internal affairs; World Courts which are given mandatory jurisdiction; a World Ombudsman to protect human rights and to keep governments from becoming tyrannical; adequate means for direct enforcement and financing; and all other agencies of a Government for Earth necessary and appropriate for peaceful, creative and sustainable living during the present and next centuries.

WORLD GOVERNMENT REQUIRES A WORLD CONSTITUTION:

Before federal World Government is established, a World Constitution is required, to define the functions, the powers, the limits, and the structure of the World Government; and to define how all of the organs, parts and agencies of the World Government will be organized and will operate together to serve human needs and the common welfare of all people on Earth. The Constitution for a federal World Government must also protect both universal human rights, cultural diversities, and the peaceful jurisdiction of national governments over their internal affairs. At the same time, the World Constitution needs to define how world government and national governments can work jointly to solve some problems and administer some affairs which have both internal and supra-national aspects.

Preparing a truly adequate World Constitution for Earth takes much time. Fortunately, a very adequate World Constitution has already been prepared over a period of nine years, and during several previous sessions of a world constituent assembly, so that no time need be lost by repeating what has already been accomplished. This World Constitution is known as the CONSTITUTION FOR THE FEDERATION OF EARTH, and is ready for immediate provisional ratification and stage-by-stage implementation, although still subject to amendments. Before final ratification, however, more countries and more people from different parts of Earth need an opportunity to review the Earth Constitution, and see if some improvements by amendment are needed.

WE, THEREFORE, ISSUE THIS CALL FOR A WORLD CONSTITUENT ASSEMBLY TO CONVENE ON THE 29th DAY OF DECEMBER, 1990.

THE PURPOSES of this World Constituent Assembly shall include the following;

1. To review the constitution for the Federation of Earth, which shall be taken as the basic document for deliberations at the Assembly;
2. To consider and debate possible amendments, and to adopt those amendments which may be deemed desirable;

- 3. To launch a final and rapid global campaign for ratification of the amended Earth Constitution by the people and governments of Earth;
- 4. To assist the continued functioning of the Provisional World Parliament and Provisional World Cabinet, already organized under Article 19 of the Constitution for the Federation of Earth, until the Earth constitution has been ratified by a sufficient number of countries or people to go beyond the provisional stage.
- 5. To assist implementation in first stages of some of the most urgent measures already adopted by the Provisional World Parliament.

THE LOCATION for the World Constituent Assembly shall be decided at a meeting of the Preparatory Committee for the Assembly before the end of 1989.

DELEGATES to the World Constituent Assembly are invited from both the national governments and the people of all countries, on the following basis:

- A. From national governments or national parliaments or executive heads of national governments ratifying this Call to the 1990 World Constituent Assembly and accepting the Constitution for the Federation of Earth as the basis for deliberations:

- One delegate from countries under 2,000,000 in population;
- Two delegates from countries between 2,000,000 and less than 7,000,000 in population;
- Three delegates from countries between 7,000,000 and less than 20,000,000 in population;
- Four delegates from countries between 20,000,000 and less than 80,000,000 in population;
- Five delegates from countries with 80,000,000 or more in population.

- B. From people or non-governmental organizations or communities ratifying this Call to the 1990 World Constituent Assembly, and accepting the Constitution for the Federation of Earth as the basis for deliberations:

- One delegate from each ratifying non-governmental organization of 5,000 members or more;
- One delegate sent jointly by several ratifying non-governmental organizations with combined total membership of 5,000 or more
- One delegate elected or appointed by a ratifying community, or by a group of ratifying communities, totaling 25,000 or more in population;
- Individual delegates securing 700 or more signatures on election petitions approved by the Preparatory Committee;
- Individual delegates who publish advertisements which explain the World Constituent Assembly and announce attendance by the delegates, such advertisements to have the approval of the Preparatory Committee and be placed in periodicals having total combined circulation of 25,000 or more for each delegate so advertising;

Together with five delegates each elected by the World Constitution and Parliament Association, and by the Provisional World Cabinet.

- C. Delegates previously accredited to the Provisional World Parliament or previous sessions of the World Constituent Assembly, must obtain renewed credentials by one of the methods defined herein.
- D. All delegates must take part in a 2-day pre-session orientation course conducted by the Preparatory Committee, before being seated as accredited delegates in the World Constituent Assembly.

DURATION of the World Constituent Assembly beginning in December, 1990, shall be as long as it may take to complete the task, in one session, or in several sub-sessions, as decided by the delegates.

ALL FURTHER DETAILS for the organization, conduct and financing of the 1990 World Constituent Assembly shall be decided and managed by a Preparatory Committee, until the Assembly, itself, assumes full responsibility. The Preparatory Committee shall be composed of delegates appointed or elected by those national governments, parliaments, or heads of national governments, and by those non-governmental organizations and communities which ratify this Call, together with acceptance of the complete plan for the World Constituent Assembly originated by the World Constitution and Parliament Association, and in company with five delegates each from the Provisional World Cabinet and the World Constitution and Parliament Association.

THIS CALL IS FORMALLY ISSUED at a meeting of the Preparatory Committee for the 1990 World Constituent Assembly on 21st July, 1989, in Washington, D.C., with simultaneous press conferences to announce the Call in various countries around the world. Signers are invited both before and after issuance.
