PROVISION OF TELECOMMUNICATION SERVICES FOR THE FORTHCOMING ELECTIONS

In anticipation of the forthcoming elections which are scheduled to take place on 27 April 1994, Telkom needs to undertake timeous planning in order to provide the telecommunications requirements of the different parties who will be involved in the election. We are especially concerned about telecommunication services that would be required at voting stations in the Self Governing States, the TBVC-countries, the outlying rural areas, squatter camps, etc.

In order to act proactively we have tried to quantify the demand for telephone services that would be required. These forecasts of telephone demand are however based on statistical information that we obtained from the Department of Statistics and other government bodies. As you will no doubt realize the forecasts are anything but accurate as the information they are based on is inaccurate. We are also aware of the fact that we would only be able to obtain more accurate details of the siting of voting stations once the Electoral Commission has been constituted. It is therefore important that Telkom explores all avenues in attempting to obtain more up to date, relevant and reliable information. Your assistance in providing information and in establishing the necessary contacts regarding the following matters would therefore be highly appreciated:

Contact with the Electoral Commission, in order to obtain the exact location of voting stations.

The telecommunications requirements of each of the voting stations or requirements in close proximity to such stations, whether they be for the Electoral Commission, political parties, international observer groups, agents of political parties, etc.

The names, addresses, contact persons and telephone numbers of any other organizations who would have an interest, contribution or a role to play before or during the elections and who may require telecommunication services, such as media representatives, radio and television broadcasters, etc.

The names of all registered political parties (or for that matter parties who would wish to participate in the elections), business addresses of the parties, contact persons and their telephone numbers.
