THE CONFERENCE

For over forty years South Africa has been isolated from the international community. As a result it is not a party to any international human rights convention and has not felt the influence of international human rights law. This situation is about to change dramatically. South Africa is about to adopt a Bill of Rights that draws heavily on the jurisprudence of contemporary international human rights conventions. In January of this

year South Africa signed (but still has to ratify) a number of human rights conventions, including the Convention on the Elimination of All Forms of Discrimination against Women

In the foreseeable future therefore, South African lawyers will be required to interpret a Bill of Rights modeled on international human rights conventions and to advise clients on their

rights arising from international human rights conventions incorporated into South African law. Likewise members of the judiciary will have to increasingly preside over cases in which the influence of international human rights is felt. Members of political parties and non- governmental organisations will also be required to be conversant with the essentials

International human rights law will soon cease to be a matter of mere academic interest and
